Elections for the following posts in Executive Council will be held during the Annual General Meeting (AGM) of the Bombay Orthopaedic Society (BOS) on **Sunday, February 26, 2023 at Hotel JW Marriott, Sahar, Andheri East**

- **PRESIDENT ELECT: 1 Post - Vacant**
(1-year term; Dr. Rajesh Gandhi will be Immediate Past President from April 1, 2023 and Dr. Sanjay Dhar takes over as President on April 1, 2023)
- **VICE-PRESIDENT: 1 Post - Vacant**
(1-year term; Dr. Satish Mutha completes his term and retires and is not eligible for re-election)
- **HON. TREASURER: 1 Post - Vacant**
(2 years term - 2023-2025; Dr. Harshad Argekar completes his term and is not eligible for re-election)
- **MEMBERS OF EXECUTIVE COUNCIL: 2 Posts - Vacant**
(3-year term; Dr. Ashish Phadnis & Dr. Abhijit Kale retire after completing 3 years in the Council and are not eligible for re-election)

Members desirous of contesting the election to these posts should **complete a nomination form and return it to the Hon. Secretary, at the Society's Office on or before 5.00 pm on February 6, 2023.**

A member may apply for **only ONE** post.

A copy of the nomination form may be obtained from BOS office.

Last date to withdraw nomination is February 10, 2023 by 5.00 pm.

Emailed nomination forms or Digital format will NOT be accepted. BOS does not take the responsibility for any postal/courier delays. In the event that the number of applying candidates is same as the number of vacant posts, there will be no election.

The candidates are expected to adhere to a high moral code of conduct.

Executive Council has appointed Dr. Sangeet Gawhale as The Chief Election Officer

All applications will be scrutinized by him in consultation with the President and the Secretary

Other rules governing the election process are mentioned below.

ELIGIBILITY CRITERIA FOR ABOVE POSTS AS PER BOS CONSTITUTION

All Members other than Overseas Members, in other words Life Members and only those with at least 5 years standing as a Member. The office bearers and members of the council shall only be those, whose addresses are registered with the office of the BOS as residents of Mumbai, Thane or New Mumbai region.

President-Elect: A candidate should be a member of BOS for a minimum period of 10 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

Vice-President: A candidate should be a member of BOS for a minimum period of 7 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

Hon. Treasurer: A candidate should be a member of BOS for a minimum period of 5 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

Executive Council Member: A candidate should be a member of BOS for a minimum period of 5 years. No previous experience as Executive Council Member is required.

ELECTION RULES

- Executive Council has appointed Dr. Sangeet Gawhale as the Chief Election Officer.
- All applications will be scrutinized by him in consultation with the BOS President and the BOS Secretary.
- Election will be conducted by Electronic physical ballot by Electronic Voting Machines (casting and counting of votes will be done by an Electronic Voting Machine)
- All candidates have to sign a declaration to their agreement for the use of Electronic Voting Machine for casting and counting the votes.
- The candidates are expected to adhere to a high moral code of conduct.
- **All forms of Electronic Campaigning should stop by 48 hours before the commencement of the Election Process, ie., 24th of February 2023 by 10.30 am.**
- **Once AGM commences, in-person campaigning must stop.**
- **Election process will start at 10.30 am during the AGM. The process will be concluded at 12.30 pm. Any member not in the voting queue by 12.30 pm will not be allowed to cast his or her vote.**
- The candidate or his (one) representative may be present during the counting process.
- Disputes, if any will be considered by a Council (President, Secretary and the Chief Election officer) and their decision is final and binding.

First, I would like to thank all my fellow BOS Members and Senior Colleagues for putting their trust in me and electing me as the Hon. Secretary of the most prestigious body of Orthopaedic Surgeons.

As I started my term, the lockdown eased out and we went back to all physical events. We successfully conducted 5 Master Series, 6 Clinical Meetings, and 12 Courses in pure physical format. For the First time, we conducted Basic Spine Course with the Bombay Spine Society in Collaboration with BSSCON which was conducted successfully. Selected Talks of Master Series were made available online on BOS YouTube Channel and OrthoTV and were very well received. The Master Series for 5th March is scheduled and a few courses remain to be conducted after the AGM.

WIROC Global and WIROC Max were conducted successfully in March 2022 and December 2022 respectively. The Bone and Joint day was celebrated and multiple events were conducted on public awareness about saving accident victims. The BOS Day was celebrated on 14th Jan by conducting an online event with an NLP Coach on Motivation which was well received.

I thank Dr. Rajesh Gandhi, BOS President for his wholehearted support to the Secretariat in bringing back BOS to the Physical Format and conducting flourishingly WIROC Max in the Jio Convention Centre.

I look forward to working with incoming President, Dr. Sanjay Dhar in the coming year with new events planned for the coming year.

FROM THE DESK OF HON. TREASURER



Respected members, hello from the treasurer of BOS Dr. Harshad Argekar. COVID is now an event we put behind us and look forward toward a world without social distancing and physical barriers. Adoption to circumstances is a mark of evolution and the society has evolved over these 3 years. Despite all odds, I am happy to report, the society finances are stable and improving. WIROC 2022 was a resounding success. Thanks to President Dr. Sangeet Gawhale and organizing secretaries Dr. Vishal Kundnani & Dr. Ashok Shyam, there was a healthy surplus from the conference. I can report that we have made a consistent increase in our corpus of funds. While in 2020 we had FDs worth 2.2 crore, this year 2023 we have 2.9 crore, and this is before closure of WIROC 22 accounts.

In my first report as treasurer in year 2020 I had suggested means to improve the BOS financial health. I had asked for directions from AGM as regards sponsorship for BOS flagship events. The members were pragmatic in their vision and gave the EC permission for the same. Positive steps taken by EC towards this has helped me get one step closer my goal of making the BOS finances independent of WIROC income. This has reduced the overall BOS expenses. All our teaching courses also have been self-sufficient and well-subscribed. I can happily report that in financial year 21-22 BOS income (other than WIROC) was higher than its expense by about Rs 7 lakh. I had also requested for members to think about endowments towards BOS as their legacy. I am happy to report that 2 senior members have contributed significantly to this end. We are using those funds to enhance the monetary award given to the winner of the Masalawala Best Paper and the Best poster award in WIROC. Both these donors have expressed their wish to remain anonymous, and the BOS EC will respect their wishes. I propose that in future and at their wishes any person making a substantial donation to BOS will have their names published in our annual report in perpetuity. Also, in future BOS directories, these names can be a part of a permanent list. updated with every new directory.

Years 2020 to 2021 we were grappling with problems related to accounting & timely tax payments, primary due to inconsistent practices & unpredictability of cash flow. I can report that this year 2022-23 I have managed to rationalize our taxes & make timely tax payments. The EC on my recommendation has appointed a new professional accountant who will do our tax & GST calculations. With this appointment, we will reduce the burden on our back office and improve coordination with our auditor. I am hopeful to achieve a zero penalty for tax payments in the coming years.

This is my last report as the treasurer. When I came to this post, I had set out certain goals. I wanted our finances to be healthy, taxes to be rationalized and our corpus to be increased. I am happy to say that I have achieved all of them. The society is closer to be financially independent from WIROC income, our taxes are paid on time, our FDs have increased. All in all, I am satisfied with these achievements. I will be updating the treasurers Bluebook to serve as a guide for future treasurers. I am extremely grateful to the 3 Presidents during my tenure Dr. Subranshu Mohanty, Dr. Sangeet Gawhale & Dr. Rajesh Gandhi, who along with the EC members helped me in achieving the goals I set. I also wish to specially thank Dr. A. J. Thakur who was a

mentor & guide for me during these 3 years. I was uniquely lucky to hold this post for 3 years due to 'electoral reform' in the BOS system and I will be happy to serve the BOS in any advisory capacity in the future.

The BOS Basic Trauma Course was held on the 23rd and 24th July 2022 at the Jupiter Hospital in Thane.

BASIC ARTHROSCOPY COURSE

The course started on Saturday, August 27th, 2022 as per the schedule with a welcome of delegates, introduction to the course and the workshops. After the first didactic session, live surgery was performed by Dr. Nicholas Antao. He demonstrated how to take the portals, diagnostic view of the joint and meniscus surgery in detail. Course inauguration was performed at 11 am by Dr. Rajesh Gandhi (BOS President), Dr. Nicholas Antao



(Head of Dept.), Dr. Abhishek Nerurkar (Course Convener), Sr. Lissy (Executive Director), Dr. Susan Sodder (Medical Director), Dr. Anuja Sinha (Asst. Medical Director) and other dignitaries from Holy Spirit Hospital. Second live surgery was performed by Dr. Rajesh Shirishkar. He demonstrated Arthroscopic Anatomical ACL reconstruction surgery. Both the live surgeries were very well appreciated by the delegates and there was good active discussion throughout the live surgeries.

In the post-lunch session, there were lectures focused on decision-making in ACL and meniscus injuries. There were five hands-on workshops conducted on the first day; basics of optics and triangulation, probing exercises, loose body removal practice and graft preparation techniques. There was a complete workshop on all inside meniscus repair with live demonstration of technique and every delegate was provided with a loaded meniscus repair device, which they fired on the meniscus model to get the feel of the repair. There were fully equipped 10 scopy stations to give ample experience for hands-on training to conclude the day 1.

The second day began with lectures on the basics in shoulder arthroscopy. After a brief session, delegates were given ten mounted dry knee models, with fully equipped optics and ACL instrumentation sets. They were first given a complete step-by-step demonstration of how to do an ACL Reconstruction by Dr. Abhishek Nerurkar, and each delegate performed the surgical steps on the dry models that were provided to them. The focus was that each and every delegate should be able to perform an ACL Reconstruction confidently after the workshop.

In the Post lunch session, delegates were taught about principles of knots followed by a workshop on Arthroscopic Knot Tying. Each and every delegate was shown how to do the knots outside the joint and pass them over the tissues. At the end, they were also provided with fibre wires, to get the exact feel of knot tying during the surgeries. The final session was dedicated to Video demonstrations and problem-solving. The course concluded with a vote of thanks from the faculty on behalf of the BOS and feedback from the delegates. The course was well appreciated and delegates were looking forward to the next one.

After the COVID bread, which necessitated online courses, a hands-on course was organised under the aegis of the BOS, at the Emerald Club, Chembur.

Initially, the number of registrations was low, upto a month before the event. However, with the advice and help of Dr. Neeraj Bijlani, our BOS secretary, we (mainly he), sent out some info on social media, following which, the numbers rapidly swelled over a week, such that by the time of the event we had 55 registrations.

The course followed a well-established programme, based on what I perceived as the learning needs of

Orthopaedic Surgeons who are not conversant with the Ilizarov method. We have conducted a similar program 5 times, with regular improvements.

This year, learning from the past, we added a couple of new teaching videos, to be run before the hands-on workshop, this year. Also, we added some Lectures in video form, from faculty members who could not make it to the event in person.

A clear learning outcome, "delegate will be able to apply a simple tibial frame or LRS for a tibial non-union, with confidence" and a course structured to meet that outcome, by way of (minimal) lectures, detailed hands-on sawbones workshops and case discussions, helped us to meet the goals of the course.

The following workshops were done.

1. Wire passing and fixation
2. Basic Tibial frame (Ilizarov)
3. Tibial Frame for Proximal/Distal Tibia
4. Tibial bone transport (Ilizarov)
5. Rail fixator for tibia
6. Rail fixator for femur
7. Demo of Deftfix Six-Axis System

There were 12 workstations, with 4 delegates per workstation. On both days, we had 1 table instructor per workstation. Table instructors were surgeons who are regularly practicing Ilizarov surgery, and having prior training in Ilizarov surgery, having done 1year fellowship previously.

The Advance Arthroscopy Course was conducted at T N Medical College and B Y L Nair Hospital, Mumbai on 7th, 8th & 9th October 2022. The Course was held after 4 years through Bombay Orthopedic Society, saw an enthusiastic response with 21 delegates registering from all over the country.

The three-day course had the Knee module on Day 1, Shoulder module on Day 2 and Cadaveric Hands-on training on Day 3. Arthroscopy Live surgeries were performed on Day 1 & Day 2 covering all aspects of Knee ligament reconstruction (Anterior Cruciate Ligament), Meniscus repair, Lateral tenodesis and meniscectomy, Bankart repair and Rotator cuff repair. Dr. Abhay Narvekar, Dr. Roshan Wade, Dr. Kumar Dussa, Dr. Prasad Bhagunde, Dr. Nagaraj Shetty performing these surgeries had a live one-on-one interaction with the delegates at each and every step of surgery by way of audiovisual communications.

Eminent faculty in the field of arthroscopy covered the topics related to ligament reconstruction, Cartilage, Meniscal lesion management, SLAP lesions, Biceps lesions, Shoulder instability, Rotator cuff lesions their management by giving focused lectures.

The Lectures were followed by very interactive discussion session where the delegate's queries regarding the different techniques, use of advance implants in basic OT set-up, post-op protocols etc. were answered to their satisfaction. Case scenarios evolved enriching discussion.

4 Workshops Sessions were conducted focusing exclusively on A) Meniscus Repair B) Graft Preparation Technique C) Suture Management Instruments D) Knot Tying Session in which the delegates had a hands-on experience with the latest implants, instruments on dry models with the continuous faculty interaction. Different techniques of graft preparation and knot tying were discussed in great details.

On Day 3 Cadaveric Arthroscopy lab hands-on full-day session was the highlight of the course. We kept 12, imported arthroscopy workstations with 12 fresh frozen cadavers assigned for these stations. 12 dedicated faculties took care of these works stations thereby making a very effective ratio of one faculty to two delegates. Each of the delegates and faculty was given a complete safety protection kit from head to toe. The delegates worked with the imported implants on these cadavers with all the imported and Indian instruments. The faculty supervised and gave their expert tips and guidance at each and every step. All the delegates appreciated the course, course content and the busy packed academic schedule.

The course was granted 4 MMC accreditation credit hour points

BOS-BSS BASIC SPINE COURSE 2022

The Bombay Orthopaedic Society collaborated with the Bombay Spine Society to hold the Basic Spine Course 2022. The course was coupled with the annual meeting of the Bombay Spine Society (BSSCON). 25 delegates attended the course which was held over a period of 4 days.

The first day's program which was conducted in the orthopaedic seminar hall at the JJ Hospital, consisted of a day-long CME program that covered lumbar disc disorders, lumbar canal stenosis, lumbar spondylolisthesis, thoracolumbar and cervical spine trauma, osteoporotic vertebral fractures, spinal tuberculosis and cervical spondylosis. Each 1 hour session involved 40 minutes of interactive case-based panel discussion followed by a 10 minutes lecture on decision-making and a Q&A session.

The second day consisted of live spine surgeries that were performed at the KEM Hospital and streamed live to delegates seated at the St. Regis Hotel, Mumbai. Six spine surgeries were demonstrated, including anterior cervical decompression and fusion, transforaminal lumbar decompression and fusion (open and minimally invasive), transpedicular decompression, posterior C1-C2 stabilization, and deformity correction in scoliosis. Additionally, edited videos of posterior cervical decompression and instrumentation as well as anterior C1/C2 release and instrumentation were shown.

On the third day, delegates attended the annual conference of the Bombay Spine Society which was held at the St. Regis Hotel. The conference was a busy affair with spine faculty from Mumbai and the rest of India participating physically while faculty from across the globe participated live online. The program was conducted in two halls and the topics covered include spinal osteotomies, safe spine surgery, thoracolumbar fractures, osteoporosis, high-grade spondylolisthesis, early onset scoliosis, failed spine surgery, adult spine deformity, cervical myelopathy, multidrug-resistant tuberculosis, endoscopic spine surgery and congenital anomalies of the craniovertebral junction. Dr. Vishal Sarwahi, an alumnus of KEM Hospital and now based in New York delivered the BSS President's invited lecture on "Neuromonitoring alerts: Sequence of events before and after", while BSS/BOS member Dr. Gautam Zaveri delivered the BSS Oration "Current trends in the Management of Metastatic Spine Tumors". Besides this, there were free papers sessions and lunch symposia which the delegates had an opportunity to attend.

A hands-on cadaver course was conducted at the anatomy dissection hall of JJ Hospital on the last day of the Basic Spine Course. Seven cadavers were available, so that the number of delegates per body was limited to 4, enabling the delegates to have maximum opportunity to perform procedures on the cadaver. Edited videos of lumbar discectomy, laminectomy, pedicle screw fixation, TLIF, thoracic pedicle screw insertion and transpedicular decompression and finally cervical laminectomy, laminoforaminotomy and lateral mass stabilization were shown to the delegates, all these procedures were then performed on the cadaver.

The feedback from the delegates was extremely laudatory. Not only were the delegates able to attend the proceedings of BSSCON but also interacted with spine faculty from all over India.

We would like to express sincere thanks to the executive of both BOS and BSS for agreeing to co-host the Basic

ADVANCED PAEDIATRIC ORTHOPAEDIC COURSE

I would like to report with great pleasure about the successful completion of the BOS "Advanced Paediatric Orthopaedic Course, 2022 - (Paediatric and Adolescent Hip disorders)". This year, we could have one of the highest number of delegates, (17) from all parts of the country as well as three international delegates. We were in fact over-subscribed by 2 and had to refuse a number of subsequent queries for registration. This year, the theme of the advanced course was Paediatric and adolescent hip disorders and we could provide the delegates an in-depth curriculum to understand most of the aspects of this difficult sub-speciality. The delegates were ranging from just post MS to almost 30 years in clinical practice. We were able to show 8 complex operative case demonstrations over the course of 3 days as well as have various lecture series on Paediatric Hip osteotomies as well as other surgeries. A few of special features which were included in this course, were the use of 3D printed bone models of some of the cases demonstrated as well as other cases discussed, so as to have very high-quality threadbare discussion of the surgeries. The second unique feature was the Hip spica workshop in which the delegates could learn the nuances of paediatric hip spica application on doll models. We had 3 high quality webinars (one for each day) with very famous national and international faculty about important topics like Perthes disease, Dysplasia as well as SCFE. The high quality of audiovisual transmission of surgeries ensured that the delegates were glued to the seats till the end and could note each and every small detail of the surgical procedure demonstrated. All in all, all the delegates were extremely happy about the course and would like to come back again.

We were able to get 4 MMC credit points for the course and all details have been provided to Mr. Vaibhav from the vama office who will do the further procedure.

From the financial point of view, also, we could finish off all expenses within the allowable amount (70% of the collected amount) and thus could show a surplus of Rs. 54,451/- (approximately).

4 Orthopaedic Surgeons (Dr. Rajiv Kapila from Kangra, Himachal Pradesh, Dr. James Kuris from Kalyan, Dr. Asgar Ali from Gurugram, Delhi and Dr. Taosef Syed from Aurangabad attended this course (there were two last minute drop outs).

The delegates assembled at Tata Memorial Hospital and observed surgeries with Dr. Prakash Nayak the entire day. They saw an intercalary resection of the femur osteosarcoma treated with cryotherapy, a proximal humerus resection for chondrosarcoma reconstructed with a nail cement spacer and implant removal for infected prosthesis with a spacer placement. On Tuesday, 17th Jan, they observed surgery with Dr. Manish Agarwal at Nanavati Max Superspecialty Hospital where they saw an intercalary humerus resection for Ewings sarcoma in an 8y old child followed by ECRT and fixation with custom made 3D printed locking plates. They then saw a wide excision of a locally recurrent thigh sarcoma. After surgeries, they had a one-to-one discussion on use of 3D printed jigs and implants and also were introduced to use of navigation in tumor surgery. They were able to physically handle the bone models and jigs used for the past cases and were able to understand their utility in those surgeries. They had a detailed discussion on extended curettage for benign tumors.

On Wednesday they attended the OPD and saw some new cases as well as follow-ups, some of which were very long-term follow-ups. They discussed these cases and understood the workup, preoperative planning and rehabilitation protocols for these reconstructions. They then attended the Pathology-radiology meeting where they saw how each case was discussed within a multidisciplinary group before a final diagnosis was reached. On Thursday, the delegates observed in the OPD at Tata Memorial Hospital. On Friday, some delegates watched an intercalary resection of femur at Tata memorial and others watched a soft tissue sarcoma resection thigh with vascular reconstruction and a muscle flap. There was a course dinner at the NSCI on Friday evening. Delegates watched surgery on Saturday morning at Tata Memorial. They then returned to their hometowns.

3. President's Address: Dr. Sangeet Gawhale

Dr. Gawhale in his address spoke

Let me wish you all a "Happy and Prosperous New Year" & hope this year pandemic comes to an end! I thank all the members of Bombay Orthopaedic Society for giving me the opportunity to serve as a President of prestigious Society, and I hope I have lived up to your expectations. This year, our theme was "ADAPT & EVOLVE". We were expecting to have physical meetings & courses, but unfortunately pandemic continued and restrictions did not allow us to meet each other. All the academic events continued as planned. Out of the six CLINICAL MEETINGS we could have only two physical meetings and the rest were virtual due to restrictions. The MASTER SHARES & MASTER CARES SERIES was also conducted on a virtual platform under the able leadership of the Vice President Dr. Rujuta Mehta. Some of the INSTRUCTIONAL COURSES were restructured as they were held on a virtual platform, most were oversubscribed and applauded by all the delegates. We had a record number of attendees. The attendance of the virtual meetings was much more than the physical one and we got excellent feedback. All the BOS activities now have MMC credit points. I appreciate the hard work put in by the Course Convenors. Based on our theme "Adapt and Evolve", we had monthly webinar on non-orthopaedic topics on last Sunday of every month. Dr. J. C. Taraporvala "POSTGRADUATE TEACHING COURSE (2021 - 2022)" was conducted in Sion Hospital. We also had "OUT REACH" program for members from periphery. On January 14, 2022 we have started celebrating the BOS Foundation Day from the current year and it will be celebrated every year on the same day as decided in the last AGM. Two newsletters "CADENCE" would be published in 2021-22. I thank our members who willingly participated in the "BONE & JOINT DAY" celebrations on 4th August, 2021 in response to an appeal from the IOA President. This year our annual meeting "WIROC" could not be held in December due to the parallel event of IOACON 21, hence it is postponed to 24th to 27th March 2022 and will be held as global event with collaboration from many International Societies. Our Secretaries, Dr. Vishal Kundnani and Dr. Ashok Shyam are working hard to make this event a great success. Lastly, I thank each and every Executive Council Member for their commitment and efforts along with the Webmasters who have worked hard throughout the year in one or the other events. I pledge my undying support to our Society and wish you all a wonderful year ahead.

4. Presentation of the Hon. Secretary's report: Dr. Swapnil M. Keny

Resilience, Resurgence and Resurrection are the words in which an Indian in general and a Mumbaikar in particular would sum up the year gone by. The Bombay Orthopaedic Society transited through a similar period of Resilience in conducting the 1st orthopaedic physical mega conference, 'WIROC Unlocked' last year, followed by resurgence of the delta variant of COVID 19, where we had to resist the urge for physical meetings, get back to a virtual platform followed by a period of resurrection where we started to build our academic goals and paths in the midst of mayhem. These times also saw a change of leadership in the BOS with Dr. Sangeet Gawhale taking over the mantle of the BOS President in the most challenging circumstances. A meticulous man who believed in the 'attention to detail', principle, he chalked out an academic path for the BOS with an apt theme 'Adapt & Evolve'. The theme proved to be the guiding principle for the BOS calendar of events. With online meetings becoming the norm rather than the exception, the flagship events of the BOS, i.e. the Clinical Meetings and the Master Shares Program were planned as online events. The Master Series session, based on the theme of 'Practice Changing Ideas in Orthopaedic Subspecialties' were a game changer and were very well attended. Similarly, each clinical meeting convener, methodically planned out the cases presented in

the meetings, in a way that each case would convey a learning point to members. The first three clinical meetings were conducted online, by Jupiter Hospital, Lilavati Hospital and LTMG (Sion) Hospital respectively while the next two clinical meetings were conducted in a physical format at the KEM Hospital and the BYL Nair Hospital. The Final clinical meeting would be conducted virtually by the Department of Orthopaedics at the Bombay Hospital. It is a matter of immense pride for the BOS that 11 out of these 12 flagship meetings were accredited by the Maharashtra Medical Council, providing an opportunity for members and orthopaedic surgeons to gain valuable credit points without any registration charges or fees before the year of registration renewal. I express my gratitude to all the conveners of the flagship meetings and the office of the BOS including our web team for this herculean effort, replicated by very few orthopaedic associations in the country. A similar trend was seen in the Instructional Courses of the BOS where in, young conveners dedicated their heart, soul and spirit to the success of their respective courses. The BOS is privileged to be the only academic body, where in, all its instructional courses were fully subscribed and at times oversubscribed, even during times of adversity. The innovation and leadership initiatives displayed by the course conveners of the BOS is nothing short of exemplary. Here, I would like to make a special mention of two course conveners, Dr. Ashish Phadnis and Dr. Satish Mutha who took up the challenge of conducting courses which were allotted to another convener, who was not in a position to conduct online courses. The history of the BOS is embedded with such stories of leadership and courage which serve as the perfect catalyst for the next generation of orthopaedic surgeons to emulate and get inspired. The year also saw the resurgence of the BOS Connect Program with the Navi Mumbai Orthopaedic Association being the invited society to host a clinical meeting on the occasion of IOA Bone & Joint Week. The Maharashtra Orthopaedic Association and the Bombay Orthopaedic Society, reiterated their camaraderie by supporting this event jointly. This was the 12th MMC Accredited program of the BOS which offered complimentary registration to members and orthopaedic surgeons. 10 The BOS President, Dr. Sangeet Gawhale was keen to have a non-academic flavor to the conventional academics of the BOS. Hence, the Adapt & Evolve webinars based on non-academic themes were held on the last Sunday of every month. These webinars covered an array of eclectic topics which were relevant to orthopaedic surgeons, including discussions on personal finance, data storage, spirituality and medico-legal aspects related to orthopaedics. These webinars were highly appreciated by the members of BOS. The BOS set its tempo and sailed uncharted territories this year by being one of the first regional orthopaedic association to start a fully digitized online membership portal. Despite certain teething issues, the initiative was a great success, especially due to the option of providing 'provisional members' to surgeons aspiring to be its members as provisional membership guaranteed a rebate in registration charges for instructional courses. The BOS EC, also took an initiative to standardize registration charges for its courses so that the courses would remain affordable to the members and trainees and at the same time be financially viable to the BOS. The BOS Treasurer Dr. Harshad Argekar, skilfully and diligently managed the financial affairs of the BOS in the academic year and I express my deepest gratitude to him. The BOS Day proved to be a Jewel in the crown of this August Association where in along with a celebrity endorsement, founding members of the BOS like Padmabhushan Prof. N. S. Laud participated enthusiastically, making the event a great success. The BOS Vice President Dr. Rujuta Mehta did a commendable job in planning and executing this event to poetic perfection for which I remain indebted to her and the team comprising of Dr. Ashish Phadnis and Dr. Abhijit Kale. At the end of the academic year and my term as the Hon. BOS Secretary, the BOS shall host 'WIROC Global' an event which promises to surpass the conferences of yesteryears. I thank the two dynamic young secretaries, Dr. Vishal Kundnani and Dr. Ashok Shyam for their effort and toil in planning the event and wish them the best of luck. I have been very fortunate in my term as the Hon. BOS Secretary largely due to the support of two strong and senior academicians as BOS Presidents, Dr. Shubhranshu Mohanty and Dr. Sangeet Gawhale. The members of the Executive Council have also been my pillars of support during this tenure. The Webmasters, Dr. Kshitij Chaudhary and Dr. Agnivesh Tikoo have responded phenomenally to the pressures of conducting online events despite their busy schedules and the editors of the BOS Newsletter, particularly, Dr. Arjun Dhawale remained a silent yet stoic support system to us. The BOS

The non-orthopaedic team of Mr. Vaibhav Pisal and Mr. Rajesh Menon have been the unsung 12th men who have held the back end of our office like the anchor in a tug of war match. Mr. Vikram Patwardhan and Vama Events have been the most efficient managers and have risen to the occasion each time. The word 'unprecedented' is a common folklore in today's times. Yet, when I think back and ponder over the last 2 years, there were no yardsticks, no guidelines and no precedents to continue the academic work of the BOS when the pandemic set in. It is only due to the unwavering and unflinching support of the member of the BOS, that our society has seen a 'Renaissance Period' during times of retribution by Mother Nature. I wish the incoming Executive Council Members the best of success and may we, the BOS move from strength to strength.

5. Presentation of the Hon. Treasurer's report and audited statement of accounts for the year 2021-22.

Dr. Harshad Argekar presented the honorary treasurer report. He said that first time we have a sponsorship for our clinical meetings amount of two lakhs from Sun pharmaceuticals. The GST issue with Alembic of 4,50,000 (four lakh Fifty thousand) has been sorted out amicably with help of Dr. Rajiv Shah and there are pending amount of Rs 5,40,000 (five lakh forty thousand) has been cleared. Income Tax refund of 7.8 lakhs has been obtained. There is a better communication with the auditor, and I recommend we continue with the same agency for this year also.

BOS fixed deposit has increased by 25 lakhs in last two years. Due to efforts made by the EC the gap between income and expense in BOS has reduced. We are still dependent on WIROC to fulfil this gap.

Dr. Argekar suggested to increase the income that we can increase the course fee of the various teaching courses we organise. This can be done by splitting the fees as, course charges & and other expenses like cadaveric lab, saw bones workshops etc.

We could also monetise BOS memorabilia by sale of BOS published books, neckties, scarfs buttons etc during WIROC.

Dr. Rujuta Mehta mentioned that, our BOS YouTube Channel has got very good views. Our many virtual programs are popular. Those programs can be promoted as pay per view. So that we can generate revenue out of this.

The Accounts were passed.

7B. Declare Best Clinical Meeting Award

The best clinical meeting was awarded to KEM Hospital Department of Orthopaedics. Honourable President Dr. Sangeet Gawhale and Honourable Secretary Dr. Swapnil M. Keny handed over the rotating trophy and a memento to Dr. Pradip Nemade and Dr. Roshan Wade who received it as representatives of KEM Hospital Orthopaedic Department.

8. To confirm the conveners for various BOS Instructional Courses for the year 2022-23

Dr. Swapnil Keny said that last year we had only basic courses. This year as per the previous GBM we will be having advanced courses this year. (as decided to have basic & advance courses alternate years). He read out the course wise received applications which are as follows:

1. JESS Course: Dr. Rajesh Gandhi
2. Basic Paediatric Orthopedic Course: Dr. Swapnil Keny
3. Advanced Paediatric Orthopedic Course: Dr. Mandar Agashe
4. Shoulder Course: Dr. Dipit Sahu
5. Hand Course: Dr. Bipin Ghanghurde
6. Electronic Skills Course: Dr. Neeraj Bijlani

There were no applications for the remaining courses.

Dr. Rujuta Mehta pointed out that there was one more application for Basic Paediatric Orthopaedic Course by Dr. Avi Shah and she herself had submitted the form at VAMA Events office in person to which Dr. Swapnil Keny replied that he hadn't received the application till the day of GBM. As Dr. Avi Shah was not there in the GBM hall (probably he was in the waiting queue for voting) Dr. Sangeet Gawhale said that we will discuss the issue when Dr. Avi Shah is in the GBM.

Dr. Rujuta Mehta said that course list was not shared or discussed in EC Meeting.

Dr. Roshan Wade suggested that we should ask VAMA Events whether the application is received or not. Later-on, on enquiry it was found that the application was submitted to VAMA Events but VAMA Events failed to forward the said application to Hon. Secretary thus causing the conflict. Hence it was decided that the said application by Dr. Avi Shah would be considered for decision in GBM provided he had fulfilled the required criteria. However, since Dr. Avi Shah was not present in the hall it was decided that the agenda is to be temporarily postponed and discussed later when Dr. Avi Shah returns back from voting process. Proposed by Dr. Neeraj Bijlani and seconded by Dr. Rajesh Gandhi.

When Dr. Avi Shah returned from the voting process, the said agenda was resumed. Dr. Rujuta Mehta said that Dr. Swapnil Keny is a senior member and now the baton should be passed on to the junior member to which Dr. Roshan Wade said that it is a GBM who will decide who is the suitable convenor rather than it is being junior or senior. Dr. Swapnil Keny said that he has applied the course only for once and it has happened in the past that many senior members have conducted the course for consecutive three years, hence it would be best that the AGM decides the matter. Dr. Deepak Govekar and other members said that they weren't aware as to who Dr. Avi Shah was and wanted to know more about him. Dr. Sangeet Gawhale asked Dr. Avi Shah as to whether he

has been a Co-Convener for previous courses as Dr. Gawhale didn't remember Dr. Avi Shah being a Co-Convener to which Dr. Avi Shah said that he has been a Co-convener before. Dr. Swapnil M. Keny said that Dr. Avi Shah was a part of the Mumbai Pediatric Orthopaedic Circle and had been a faculty at pediatric orthopaedic meetings. Dr. Mandar Agashe said that were the applications evaluated by judges, to which Dr. Swapnil M. Keny said that since that he had not been given Dr. Avi Shah's application, there was no question of evaluating it.

Dr. Alaric Aroojis reiterated what Dr. Rujuta Mehta said to which Dr. Swapnil Keny agreed to withdraw the application.

Dr. Roshan Wade said that no members should pressurise Dr. Swapnil Keny to withdraw the application and general body would rather like to listen what Dr. Avi Shah has to offer in the paediatric orthopaedic course because like him many don't know about Dr. Avi Shah in details. Dr. Govekar said that he would support what Dr. Roshan Wade said. Dr. Sangeet Gawhale said that Dr. Shah should work together with Dr. Swapnil Keny and he can take Dr. Keny as co-convener to conduct the course, to which Dr. Rujuta Mehta again objected saying that it is the right of the convener to choose the co-convener. Dr. Ram Chaddha said that let us not put a rift in between the paediatric group and let both of them work together. So it was decided that that Dr. Avi Shah and Dr. Swapnil Keny would do the course as Convenor and co-convener respectively.

Proposed by Dr. Sangeet Gawhale and supported by Dr. Ashish Phadnis.

On the matter of members not being present in the AGBM because of being present in the voting queue, Dr. Roshan Wade commented that it is shameful that members are not able to participate in AGBM because of voting queues simultaneously. He said that society's growth is because of members direct participation and he suggested that AGBM can be conducted during annual WIROC conference where majority of the members can attend the AGBM in person and election can be taken as a separate process to which Dr. NS Laud commented that why shouldn't the voting be online considering the technological advancements in today's era. Honourable President reminded that it amounts to constitutional amendment.

Dr. Vikas Agashe suggested that when an applicant applies for the instructional course we should acknowledge his application by sending him a mail. Dr. Harshad Argekar raised the query about the shoulder course and asked where is Dr. Dipit Sahu going to conduct the Shoulder Course to which Hon. Secretary replied that it will be conducted at KB Bhabha Hospital and Dr. Babasaheb Ambedkar Hospital.

Hon. President Dr. Sangeet Gawhale invited application from the house for the remaining courses for which there were no prior application.

There was no application from the house for Basic Fracture Fixation Course or Advance Trauma Course.

For Basic Spine Course, Dr. VT Ingalkar expressed the interest, and it was allotted to him. Advance Spine course was allotted to Dr. Gautam Zaveri. Dr. Abhishek Nerurkar expressed the desire to conduct Basic Arthroscopy Course, to which Dr. Harshad Argekar commented that Dr. Nerurkar has never been convenor or a co-convener for any other course so it was decided that EC will decide about the Basic Arthroscopy Course and all other remaining courses.

Hon. President Dr. Sangeet Gawhale mentioned it has been observed that many appointed course convenors are taking the decisions unilaterally and they do not follow the general guidelines and he has received some complaints from the national faculties. He also said that there should be strict rules for the course convenors and all course convenors should adhere to those rules.

He also said that only BOS members should be invited (preferred) as faculties for the courses and academic events. Dr. Gautam Zaveri said that, EC should come down strictly on the convenors who are not following the rules. All the convenors (course convenors) must adhere to the guidelines.

To this, Dr. Sangeet Gawhale said that, it has been done already but what should be done for the convenors

who are self-glorifying themselves and not following the uniform rules & using this platform for self promotion. To which, Dr. Ram Chaddha asked how can we prevent all these things and what actions can be taken? He suggested that allow Vice President to implement the academic rules and regulations. Nothing can be done for the things which have already happened but if it happens in future then the person should be debarred from the course convenorship in future which Dr. Sangeet Gawhale said if the house agrees then we can put up these rules.

Dr. Rajesh Gandhi asked can we cancel the course if the convenor does not submit the program at least two weeks before the course commencement? Dr. Vikas Agashe said that if course convenor does not follow the order then he should be reprimanded. By cancelling the course we are doing injustice to the delegates who have applied for that course.

Dr. Mandar Agashe said that all the convenors should be given time up to 3 weeks for the submission of their expenses.

Dr. V. T. Ingalthalikar said that we must set up some mechanism to check the courses.

Proposed by Dr. Sandip Sonone and supported by Dr. Ram Chaddha.

9. WIROC Unlocked - Organising Secretary's Final report & Accounts: Dr. Mandar Agashe, Dr. Satish Mutha

Dr. Mandar Agashe and Dr. Satish Mutha presented a report about annual conference WIROC Unlocked that was conducted in March 2021. They cited the difficulties that they faced during the Covid pandemic and how they have kept all the plans ready just in case that one plan fails. They said that it was the major conference in physical format in Covid pandemic and they have constructed the event in a hybrid format and it was 1st event to work collaboratively. They added that all the Covid protocols were followed and there were 450 registration, rather they had to refuse registration because of the Covid protocols.

There were more than 50 trade partners and all social distancing norms are followed. The event included the collaboration of eight institutes and the unique feature of the event was presence of Mr Ratan Tata for the inaugural ceremony. The financial lecture by Dr. Nitin Bhagali was a big hit and inspirational talk by Mr. Chetan Bhagat was also good. There was no Covid-19 mishap following the event. Dr. Mandar Agashe and Dr. Satish Mutha thanked Dr. S. S. Mohanty, Hon BOS President at a time and the entire Executive Council, the Scientific Committee, Mr. Rajesh Menon and Mrs. Amrita, the trade partners, audiovisual Mr. Peter Anand, Vama Events team and finally all the delegates attending the event. The total profit from the event was 19 lakhs.

Dr. Rajesh Gandhi announced the organising secretaries of WIROC 2022-23 as Dr. Ashish Phadnis and Dr. Abhijit Kale.

12. Proposal to host WIROC 2022 outside Mumbai at Amby Valley

Dr. Ashish Phadnis made the presentation about possibility of conducting WIROC 2022 outside Mumbai at Amby Valley as one off event as we are coming out of Pandemic and we are going to have two WIROC's in same year.

Dr. Satish Mutha asked about the cost escalation to which Dr. Rajesh Gandhi replied that only 10% cost escalation will be there from the present slab of residential package in WIROC Global.

Dr. Rujuta Mehta said that it is prerogative of Dr. Rajesh Gandhi as President of the organization to host the Conference at venue of his choice and hence we should support him.

Dr. Vikas Agashe said that WIROC's main purpose is to address the academic needs of a large population of surgeons in the Mumbai and it's a good training ground for everyone. In Amby Valley, it will restrict the number of delegates; that the non-residential delegates will find it difficult to communicate to commute daily and for the residential delegates the expenditure will be more. Many practitioners in Mumbai like to keep continue their practice during the conference and it will be very difficult for them to continue doing so at personal level. He said that out of Mumbai it is not a good venue for WIROC.

Dr. Roshan Wade said what is Plan B in case this plan of Amby Vally does not succeed, as it had failed in the past, to which Dr. Ashish Phadnis replied that plan B is ready. Dr. Tushar Jimulia said that WIROC is a Western Indian Regional Orthopaedic Conference and we all can enjoy at new venue and come back and we must try out a new venue.

Dr. Sandeep Sonone said that Dr. Agashe's remark of difficulty to travel outside Mumbai is valid. But, as a solution to that, we can conduct the conference in hybrid manner so that those who cannot travel for attending the physical conference can attend it online. Dr. Vishal Kundanani said that during the pandemic we are saturated and everybody is asking the question what next why should not we go out of Mumbai and explore the new venues.

Dr. Ashit Rao mentioned the history that in the past, there were no other societies or associations and that's why BOS meetings were conducted outside Mumbai. However currently, each district and state has their own societies and associations. So the purpose of WIROC is to cater to the academic needs of Mumbai. As far as question of enjoying is considered a picnic can be organised to address the need of rather than holding an academic conference. Dr. Rajesh Gandhi replied by assuring that academics will not be diluted by holding a conference at Amby Valley.

Dr. Anand Thakur said that past AGBMs had decided to hold WIROC in Mumbai only as a signature event of Bombay Orthopaedic Society. He expressed the question of what is the need of holding the conference outside Mumbai and by holding the conference in Amby Valley we are forcing some people not to come for the conference. Dr. Prakash Samant said that on weekends, there is a lot of traffic at Amby Valley as the connecting road from Lonavla is very narrow. On Friday and Saturday, there is a massive traffic jam. As far as accommodation is considered at five-star sister hotels there are lots of people staying on the weekend and we may find it difficult to get rooms. He suggested that it should be kept on working days rather than on weekends to avoid the problem of traffic and accommodations.

Dr. Satish Mutha asked the about the capacity of Amby Valley on weekends to which Dr. Rajesh Gandhi replied that 378 rooms are assured on a twin sharing basis which accounts for 750 people's accommodation and they have contacted other hotels in Lonavla, hence more than 1000 people can be accommodated. Considering that, Dr. Satish Mutha asked about the cost escalation to which Dr. Rajesh Gandhi replied that only 10% cost escalation of the present slab of registration will be there if at all.

Dr. Rujuta Mehta said that since Dr. Rajesh Gandhi is elected un-opposed, he has the faith of the BOS and it is President's prerogative to hold the WIROC. What we have to debate today is whether we have faith that he

will do the best. We should support Dr. Rajesh Gandhi on this point to which Dr. Sangeet Gawhale replied that we are discussing only about holding conference at Amby Valley and it's not about supporting anyone. Dr. Vikas Agashe replied that supporting Dr. Rajesh Gandhi and supporting conference at Amby Valley are two different things and these things should not be mixed.

Dr. Prakash Samant said that three years back it was 25,000 on twin sharing basis which Dr. Rajesh Gandhi said that it will be only 10% increase.

Dr. A. J. Thakur asked that what is your solution to traffic jam.

Dr. A. B. Goregaonkar said that each WIROC has had some or the other issue. For years we have been holding WIROC at 5-star hotel and it's time that we try out other venues. In future we may have all WIROCs at other venue.

Dr. Niraj Bijlani mentioned that money should not be a criteria to decide venue of conference as there is nothing called as a poor orthopedic surgeon. Dr. Roshan Wade said that we cannot forego the opinion of senior members. This is not issue of Amby Valley, this is the issue of for the everyday practitioners and residents and industry also. There are repercussions of holding conference outside Mumbai. The next conferences may be held in Goa, Colombo or some other place in the World.

Dr. Prakash Samant asked if any other conferences are happening at Amby Valley; to which Dr. Phadnis replied that in fact there are many conferences that are happening at Hotel Renaissance so we may not get the dates.

Dr. Sudhir Sharan said that as a society we should stand together and give a new idea a chance.

Dr. Tushar Jimulia added that the seniors of Bombay orthopaedic society will be present at all times in the non-Mumbai location and thus they can influence the juniors for a longer period of time. Thus as a majority decided and it was passed that WIROC-2022 may be conducted at Amby Valley

Proposed by Dr. Neeraj Bijlani and Seconded by Dr. Rujuta Mehta.

13. To confirm the names of speakers for the R. J. Katrak Oration and the K. T. Dholakia Lecture for WIROC 2022 and select stand-by speakers who will be the confirmed candidates for WIROC 2023.

Dr. Swapnil Keny informed the house that for Dr. Katrak oration would be Dr. Sanjay Agarwala who had agreed to deliver the oration and for Dr. K. T. Dholakia lecture, the speaker would be Dr. Ravi Ramakantan. However, Dr. Ramakantan has expressed that due to health issue he may not be able to attend if the conference is held out of Mumbai.

Dr. Agashe said that in case he is not able to travel outside Mumbai, we should give him an option of online delivery of the oration.

Standby speaker for Katrak would Dr. Anant Joshi and he will be the Orator for WIROC-23. For the Dr. K. T. Dholakia Oration, Dr. Sangeet Gawhale suggested that the names of Dr. MunJed Al Muderis from Macquarie University Australia or Dr. Jason Stoneback from University of Colorado who had done pioneering work on osteointegration and Dr. B Ravi from IIT Mumbai was suggested by Dr. Rajesh Gandhi. Dr. Agashe said that he supports the name of Dr. B. Ravi. Dr. Ram Chaddha said that Dr. K. T. Dholakia Oration is a non-clinical topic and didactic in nature so we should we could keep it online, thus saving a lot of money for travel and accommodation of the speaker to which was supported by Dr. Harshad Argekar.

Dr. Ram Chaddha made a proposal that future didactic lectures may be kept online.

Dr. Rajesh Gandhi made a suggestion that Dr. B. Ravi can be kept as a speaker for K. T. Dholakia Oration for year 2022 in case Dr. Ramakantan cannot travel to Amby Valley and Dr. Ravi Ramakant may be shifted as a speaker for the following year.

Proposed by Dr. Rajesh Gandhi and Seconded by Dr. Vikas Agashe.

14. To approve applications for BOS membership

16. Any other matter with the permission of the chair

1. Dr. Swapnil Keny informed the house about a letter written by Dr. Aseem Parekh, Past President of the BOS, about publishing the addendum to the Past President's book which was published during the Golden Jubilee year of WIROC. Dr. Vikas Agashe commented that it would be a very costly affair and for saving money only the names that has been added after publishing the previous book should be printed.

Dr. Ram Prabhoo said that we should make a policy that such book can be published every five or 10 years.

Dr. Sanjay Dhar said that this book can be in PDF format and sent to every member.

Dr. Sangeet Gawhale has informed the house that one BOS member who wishes to stay anonymous has agreed to give a donation for printing this book.

Dr. Neeraj Bijlani said that we should send PDF of the book to everyone and give the printout only on request on feeling a certain form to which Dr. Ram Prabhoo and Dr. Harshad Argekar supported.

Dr. Satish Mutha said that should we discuss this matter if a person who wrote this letter is not present in the hall. He said that the book can be published every five years. So it was proposed that the Addendum book may be published online and hard copy will be provided to members on request.

Proposed by Dr. Sanjay Dhar and seconded by Dr. Neeraj Bijlani.

2. Hon President Dr. Sangeet Gawhale informed the house that the BOS Member who wishes to stay anonymous has agreed to give a donation of two lakhs Indian Rupees and has requested that the prize money for the Young Surgeon Forum and Veteran Surgeon Forum of Rs. 20,000 each for the first five years should be made available from the donation. Dr. Gawhale also added that Indian Arthroplasty Association has made a donation of 5 lakhs, (courtesy Dr. Shubhranshu Mohanty) and we can make the same provision for next five years from this 5 lakhs; thus the provision for 10 years can be made.

At this juncture, Dr. Gawhale invited Dr Mohanty to speak about this donation)

Dr. S. S. Mohanty informed the house that the annual conference of IAA was supposed to happen in Coimbatore but because of Covid protocols it was supposed to get converted to virtual format. However, he as an Organising President of IAA & Dr. Harish Bhende as and Organising Chairman agreed to do the conference in physical format in Mumbai and they did not have adequate time for preparation. They had received great support from the BOS for getting delegates and MMC approval and that's why they could conduct the conference flawlessly with the help of the BOS. As a token of appreciation and goodwill gesture, the IAA Organising Committee decided to give a donation of five lakh Indian rupees to the BOS. He thanked BOS President and Hon. BOS Secretary for the same.

Dr. Sangeet Gawhale thus inform that the provision for next 10 years for YSF and VSF, prize money of Rs 20,000 each can be made out of these donations.

Dr. Sangeet Gawhale also proposed that the cash prize for Dr. K. S. Masalawala Best Paper Award which is currently Rs. 5,000 can be increased to Rs. 15,000.

Proposed by Dr. Sangeet Gawhale and seconded by Dr. Roshan Wade.

3. Dr. Agashe mentioned that by the time surgeon becomes eligible to practise and get his patients for the follow up he is almost over 40 years of age so it is high time we decide the cut-off age for the YSF. He proposed that age should be increased to 45 years of age. He also said that there is hardly any criteria for YSF because it is just a published paper so he said that some criteria should be laid down and it should be decided whether it is just for 30 minutes of plenary session, to which Rajesh Gandhi supported.

Dr. Sanjay Dhar said that there should be special committee to judge YSF or VSF and it should not be decided by the scientific committee. This committee should know the name of the presenter, they should be able to interview the presenter and there should be different criteria rather than just accepting the paper.

Proposed by Dr. Sangeet Gawhale, Seconded by Dr. Sanjay Dhar.

Dr. Prakash Samant said that as per NMC guidelines, 10% of plagiarism check should be allowed. Presenters should self attest such declaration that the papers is within 10% plagiarism limit.

Dr. Ashok Shyam said increasing the age for YSF should help the surgeon to collect prospective data.

Dr. S. S. Mohanty the cut-off age of 45 years and he asked that whether can we cut down the presentation time to 20 minutes (that is 15 minute presentation and five minutes for felicitation and formalities), to which Dr. Gawhale said that is it that it should be 18+2.

Dr. Agashe said that to say that 20 minute is too less and he proposed 20 minutes talk +5 minute for felicitation. Thus, it was decided that the timing should be 20 minutes presentation and five minutes for felicitation and formalities.

Dr. Swapnil Keny asked Dr. Agashe that since the cut off for the YSF in IOA was 50 years why the same may not be done for the BOS, to which Dr. Agashe said that 45 years seems to be the right limit at present.

Proposed by Dr. Sangeet Gawhale and seconded by Dr. Ashok Shyam.

4. Dr. Swapnil Keny informed the house about a letter submitted by Dr. V. T. Ingalthalikar about the BOS song or anthem. Dr. Ingalthalikar presented the BOS song and asked the General body to give opinion about it and he said that it is a raw version and it will be changed to a more professional version. Dr. Swapnil Keny said that there can be a video bites that can be present during the song. Dr. Sangeet Gawhale said that the time allotted for inauguration is very less, that is 15 min only. A two minute song can consume the time during inauguration. Dr. Agashe and Dr. Ram Prabhoo said that the song should not consume the time of inauguration. Dr. Ram Chaddha said that said song cannot be called as an anthem because we call it as an anthem then there are rules and regulations about that and it is humanly impossible for the members to stand for two minutes for the said song. He said that it would hurt the composer if the song is not respected so it should be just called as a song and not as an anthem.

Dr. Roshan Wade supported the Dr. Chaddha and added that it should be played on the BOS foundation day rather than WIROC.

Dr. Pradip Nemade said that since the song was not invited executive council and submitted by the member on his will, there could be more such submissions in the future and we should not discourage other members in submitting the song just because we have still already selected one song.

Proposed by Dr. Sangeet Gawhale supported by Dr. Sandeep Biraris

17. Felicitation of BOS Course Conveners for the Academic Year 2021-22

WIROC GLOBAL: A Mega-Event

WIROC GLOBAL was a fantastic experience for all three of us, and we hope it was for all the delegates and faculties.

It represented a change and a transition from the virtual world into a physical conference. It had the best of both worlds included in one which did full justice to the presidential theme of Dr. Sangeet Gawhale; 'Adapt & Evolve.'

The entire event was planned in 3 months! Yes, just three months is what was needed to plan and execute a conference of such a massive scale. And we thank the entire team with us that has helped us realise this dream.

The first proof of concept was the balance of Virtual and Physical components and the involvement of National and International Societies on One Single Platform. The concept and term 'WIROC GLOBAL' was suggested by Ashok Shyam and was readily accepted by the other pillars of WIROC and thus began a journey of partnership, friendship, and comradeship among all of us three.
