# NOTICE FOR THE ANNUAL ELECTION OF BOMBAY ORTHOPAEDIC SOCIETY



Elections for the following posts in Executive Council will be held during the Annual General Meeting (AGM) of the Bombay Orthopaedic Society (BOS) on **Sunday, March 10, 2024 at Jio World Convention Centre, BKC**

- **PRESIDENT ELECT: 1 Post - Vacant**  
(1-year term; Dr. Sanjay Dhar will be Immediate Past President from April 1, 2024 and Dr. Mohan Desai takes over as President on April 1, 2024)
- **VICE-PRESIDENT: 1 Post - Vacant**  
(1-year term; Dr. Naushad Hussain completes his term and is not eligible for re-election)
- **HON. SECRETARY: 1 Post - Vacant**  
(2 years term (2024-2026); Dr. Neeraj Bijlani completes his term and is not eligible for re-election)
- **MEMBERS OF EXECUTIVE COUNCIL: 2 Posts - Vacant**  
(3-year term; Dr. Sandeep Biraris & Dr. Pradip Nemade retire after completing 3 years in the Council and are not eligible for re-election)

Members desirous of contesting the election to these posts should complete a nomination form and return it to the Hon. Secretary, at the Society's Office on or before 5.00 pm on 25th February, 2024.

A member may apply for only ONE post.

A copy of the nomination form may be obtained from BOS office.

Last date to withdraw nomination is February 28, 2024 by 5.00 pm.

Emailed nomination forms or Digital format will NOT be accepted. BOS does not take the responsibility for any postal/courier delays. In the event that the number of applying candidates is same as the number of vacant posts, there will be no election.

The candidates are expected to adhere to a high moral code of conduct.

Executive Council has appointed Dr. Rajesh Gandhi as The Chief Election Officer

All applications will be scrutinized by him in consultation with the President and the Secretary. Other rules governing the election process are mentioned below.

## ELIGIBILITY CRITERIA FOR ABOVE POSTS AS PER BOS CONSTITUTION

**All Members other than Overseas Members, in other words Life Members and only those with at least 5 years standing as a Member. The office bearers and members of the council shall only be those, whose addresses are registered with the office of the BOS as residents of Mumbai, Thane or New Mumbai region.**

**President-Elect:** A candidate should be a member of BOS for a minimum period of 10 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

**Vice-President:** A candidate should be a member of BOS for a minimum period of 7 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

**Hon. Secretary:** A candidate should be a member of BOS for a minimum period of 5 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

**Executive Council Member:** A candidate should be a member of BOS for a minimum period of 5 years. No previous experience as Executive Council Member is required.

- The candidates are expected to adhere to a high moral code of conduct.
- **All forms of Electronic Campaigning should stop by 48 hours before the commencement of the Election Process, ie., 8<sup>th</sup> of March 2024 by 10.30 am.**
- **Once AGM commences, in-person campaigning must stop.**
- **Election process will start at 10.30 am during the AGM. The process will be concluded at 12.30 pm. Any member not in the voting queue by 12.30 pm will not be allowed to cast his or her vote.**
- The candidate or his (one) representative may be present during the counting process.
- Disputes, if any will be considered by a Council (President, Secretary and the Chief Election officer) and their decision is final and binding.

As I transition from this role, I am eager to continue my association with the Bombay Orthopaedic Society in any capacity possible, contributing to our society's growth and success.

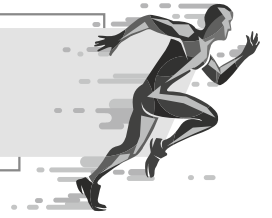

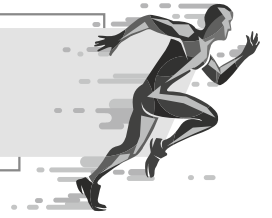

# GUIDELINES FOR BOS COURSE CONVENERS



## A) ACADEMIC/ADMINISTRATIVE

1. Conducting a BOS course should be a privilege and all attempts should be made to uphold the reputation of BOS as an academic body while conducting these courses. The academic content and the faculty should be of the highest standard.
2. Certificate of participation signed by Convenor, President and Secretary as per the set format of BOS. If course accredited by MMC - MMC Observer sign will be required.
3. On the course banner, only the following names can be printed: Convenor, President and Secretary as per the set format of BOS. Any promotion of the course on social media must have aegis of BOS course written prominently.
4. It is preferable that application to MMC for Accreditation points to be done by Convener directly and not leave it to the BOS Office. If you need help from BOS Office, please obtain prior permission of the BOS Secretary to do so. It shall be the responsibility of the Convener to upload the attendance and comply with all the MMC requirements. Upload attendance within one week of completion of the course.
5. Please furnish a report of the course along with the bills within 15 days of completion of the course and a detailed report of the attendance and Delegate feedback. For the courses which are being held in November and December, the report to be submitted latest in 15 days after the course is over or by 15th December, whichever is earlier for publication in the annual report.
6. Selected candidates must be intimated timely as regards their selection and timings of the course, so that they can make their travel plans well in advance.
7. All due permissions from higher authorities in the respective institutions through HOD Orthopaedics and other allied departments, Dean permissions must be taken 2 months in advance, auditorium bookings etc. must be ensured to avoid last minute cancellations and embarrassment to BOS.
8. Courses, who do not receive at least 50 percent of applications 15 days prior to the event, may be scrapped if not viable. Due efforts must be made to popularise and advertise the courses if it is known prior that there are not enough applicants. At least one month prior to the event, the course quorum must be complete.
9. The tentative program must be submitted to BOS Office for update on website and e-mailers preferably 2 months prior to actual event.
10. If a delegate is absent for the full course, you are expected to intimate the same immediately to BOS Office.
11. Bombay Orthopaedic Society is not responsible for any ill health or hospitalisation of delegates during the course, or any travel reimbursement of the same.
12. Please maintain good and efficient communication throughout the course with your delegates. You may add the BOS Secretary and Treasurer if forming a Whatsapp group. However, it is not acceptable to submit bills on Whatsapp. Physical copies are to be delivered to the Secretariat or scanned copies on e-mail with a detailed covering letter. BOS Office will not arrange for the collection of the same.
13. Feedback forms must be submitted online only. After verification of which the certificates will be issued to the delegates.

## B) COLLECTION AND DISBURSING OF FUNDS FOR BOMBAY ORTHOPAEDIC SOCIETY COURSES

1. The course fees should be in moderation. There is a GST of 18% on the course fees. There is a quantum of administrative charges, staff, banners, certificates, feedback, emailer and mass SMS (only 3 per course allowed). As a rough estimate, 25% of the course fees should be kept aside for above reasons and only balance 100 - 43 (18+25) 60 percent be spent. Amount Exceeding 60% of the collected revenue will not be sanctioned by the Executive Council under ANY circumstances.
2. All courses are expected to make a profit of at least 15% of the gross collection. Spending on faculty welfare should be minimum. Gifts to the faculty are NOT allowed. No mementos will be given to any faculty member during the course. Thank you letters to participating faculty as a courtesy must be arranged within 48 hours of the event.
3. The budget should be submitted before declaring as awarded in GBM; GBM should have only the list of decided courses with breakup of what the expenses are for. Any convener exceeding budget for 2-3 consecutive courses should be barred/fined.
4. BOS will not pay for instruments for any course as per AGM mandate. If instruments are taken on BOS name as a donation, prior intimation to the Secretary and Treasurer is mandatory. They need to be deposited at the end of the course within a week with a detailed list with the Treasurer, with an accompanying covering letter by the respective company.
5. Course dinner is not essential part of whole show. If planning it, make sure you are able to manage it within the budget allocated. Payment for catering bills should not be made in cash and Society is willing to issue a cheque in advance; money may also be paid by individual's credit card and Society will reimburse him by issuing a cheque. Personal Cheques and Credit Cards are acceptable mode - reimbursement by the Society is easy. For amounts more than Rs. 1,00,000/-, PAN card number of the payee is essential.
6. All sponsors must make their contribution to BOS; Sponsors of a BOS event should not give money directly to a Convener. It must come to Society's account and then spent for specified event. Sponsors are not expected to display their commercial visuals, banners etc. inside a meeting hall; all displays should be outside the meeting hall.
7. Payment in cash for bills higher than Rs. 30,000/- will not be allowed by the Executive Council as the Society cannot claim it as expenses. As internal policy, BOS wants to minimize spending in cash; such expense should only for tips, and for small expenses lesser than Rs. 2,000/-.
8. If you need to pay any advance for conducting the course, please feel free to contact the Secretary or Treasurer at least 15 days prior to conducting course, we will make the arrangement for the same.
9. Please keep the expenditure within the total amount of course fees. If for some reasons you are likely to shoot the budget, you are requested to take prior permission from the BOS EC for the extra expenditure. Let the EC ratify / grant permission for the extra expenditure and then only go ahead with the same. For any special requirement, please submit prior quotation and justification and get it approved by the Secretary / Treasurer.
10. BOS will not pay rental charges to private clinics for the conduct of a course, implants for the patient, anaesthesia charges or consumables for the same.

## C) FLAGSHIP EVENTS OF BOS

1. a) JCT Memorial PG Clinics: Voucher payments for basic tea, coffee and refreshments will need the bill to Bombay Orthopaedic Society written clearly. Any other sundry minor expenses may be sanctioned with prior intimation to the BOS. If organising a lecture series, standard MMC application rules will apply.
2. b) Clinical and Master series meetings
  1. The present expense limit for such events is Rs. 35,000/-. Part sum may be given in advance to the Convener in cash; as internal policy, BOS Wants to minimize spending in cash; such expense should only be for tips, and for small expenses lesser than Rs. 2,000/-. All food bills for various meets and courses should be paid by cheque; all caterers connected with Medical College canteens have PAN cards and can take cheques. Money can also be paid by individual's credit card and Society can reimburse him by issuing a cheque.
  2. All Clinical Meets, Master Series and Course Conveners are expected to submit their accounts within 15 days of completion of their events along with the Convener's report. All such bills are checked and settled if found in order within 3 weeks of submission to Society's office. EC will take a serious note of late submission of expense sheet and course report; this may be taken against a Convener for future activities.
  3. Any payment made on behalf of BOS must be supported by an invoice (bill); for small amounts paid in cash it must be supported by a voucher signed by the concerned person. All bills must be collated and countersigned (approved) by the concerned conveners. Vendors are discouraged to submit the bills to Society's office. All these bills are seen and approved (signed in red) by the Hon. Treasurer before a cheque could be released. All cash expense vouchers should be countersigned by the Hon. Treasurer.
  4. Please furnish all the bills together bearing your signature after the course, so that payment can be done immediately at one instance. Please see that the payment is made by cheques as far as possible. Preferably 80% to 90% of payment should be done by Cheques. All expenses to be supported by bills and vouchers.

The BOS Foot & Ankle Course 2023 was held from 22<sup>nd</sup> - 23<sup>rd</sup> July 2023 at Lokmanya Tilak Municipal Medical College and General Hospital, Sion, Mumbai and received overwhelming response. Ten delegates registered and attended the course over 2 days.

During the 2 days course, 7 live surgeries were demonstrated to the delegates in 3 OTs. The delegates were allowed to enter the OT and observe the commonly performed procedures live with technical tips and tricks to perform the surgeries.

Also concept based talks on important topics in ankle & foot were delivered during the course. Additionally, clinical cases were discussed in case-based panel discussion session highlighting the thought process required to plan a solution for difficult case scenarios.

Also, cadaveric demonstration was held on Day 2, during which delegates performed Ankle Arthroscopic procedures on the cadavers and different approaches were demonstrated by faculties. The cadaveric session was most awaited as well as most appreciated part of this course.

The total teaching was 16 hours over 2 days.

The course was graced by eminent foot & ankle surgeons across the country and faculties - delegates interaction was maximised to solve the delegates queries and improve their learning.

All the delegates participated actively during the question and answer session and panel discussion. The junior and budding Foot & Ankle surgeons were also accommodated as case presenters and they also worked as table instructors in arthroscopy & cadaveric dissection sessions. #### Course Details

**Day 1:** The first day of the course was held at the Mangal Anand Hospital, where 2 live surgeries on Knee deformity correction and Limb Lengthening using the Ilizarov fixator were demonstrated.

This was interspersed with interesting case discussions.

A workshop on Osteotomy rules and paper planning for osteotomies for deformity correction was conducted.

**Day 2:** The second day of the course was held at the Reliance Foundation, Sir H. N. Hospital. A live surgery on High Tibial Osteotomy for medial compartment OA was demonstrated. This was followed by lectures by eminent specialists from all over the country via a web telecast.

The lectures were followed by a 3D printed Jig based deformity correction workshop and a hands-on Saw Bone Workshop for High Tibial Osteotomy.

**Day 3:** The final day of the course was held at the K. B. Bhabha Municipal General Hospital, Bandra. Three Live Osteotomy surgeries on Varus Osteotomy for Coxa valga, Osteotomy for Genu Valgum and an Osteotomy and deformity correction for a malunited intraarticular wrist fracture were demonstrated.

The live surgery demonstrations were interspersed with case discussions.

A symposium based on the theme of 'Planning and Executing Osteotomies in Pediatric Orthopaedic conditions' was conducted in the later part of the day.

The delegates were interested, interactive and gave a positive feedback and suggestions for conducting the course in the future.

The BOS Arthroplasty Course 2023 was held from 10<sup>th</sup> March to 12<sup>th</sup> March 2023 at Lokmanya Tilak Municipal Medical College and General Hospital, Sion, Mumbai and received overwhelming response. Thirty-seven delegates registered and attended the course over 3 days.

During the 3 days course, 4 inbox surgeries (recorded & edited) of commonly performed arthroplasty procedures were demonstrated in Video module session, 8 short surgical videos covering small yet important part of a surgery with technical tips and tricks were relayed in surgical vignettes session.

Also 12 concept based recorded talks on important topics in knee and hip arthroplasty were delivered during the course. Additionally, 10 clinical cases were discussed in case-based panel discussion session highlighting the thought process required to plan a solution for difficult case scenarios.

A new and innovative feature of this year's course was breakout sessions were arranged during which delegates interacted with faculties on one to one basis to clear their doubts. Saw bone workshops were conducted during which delegates practised cuts in hip and knee arthroplasty under supervision of subject experts.

Also, cadaveric demonstration was held during which delegates performed TKR and THR on the cadavers and different approaches were demonstrated by faculties. The cadaveric session was most awaited as well as most appreciated part of this course.

The total teaching was 20 hours over 3 days.

The Annual General Body Meeting was conducted at Hotel JW Marriott Sahar, Andheri, Mumbai on Sunday, 26<sup>th</sup> February, 2023. The meeting was convened at 9.15 am after the quorum was met.

The Published Agenda was followed:

## 1. CONDOLENCES

The society paid its solemn condolence to the souls of its bereaved members. Condolence were paid to Dr. Ashok Pagrut. Dr. Rajesh Gandhi said that he was an avid trekker and was very fit physically. God bless his soul. Condolence were also paid to Dr. G. B. Kale from Vasai. Dr. Roshan Wade said that Dr. Kale was an avid trekker, loved riding bikes and loved farming. He initiated the formation of Vasai Virar Orthopaedic Society. He drove a heavy truck from Mumbai to the north east. Dr. Vikas Agashe too said that he remembered his presentation of driving a truck to the north east which was presented in the then WIROC. He remembered him as a brilliant and a well-read student and they used to attend clinics together and appeared together for the exam.

## 2. TO CONFIRM AND PASS THE MINUTES OF THE AGM HELD IN FEBRUARY 2022

Dr. Neeraj Bijlani said that there was no leave of absence received. Dr. Sangeet Gawhale pointed out that in the minutes of last AGM, page 44, point 8, 4<sup>th</sup> paragraph - it read that Dr. Avi Shah and Dr. Swapnil M. Keny will do the Basic Paediatric Course. but on page 27, the course report stated that the names of the co-conveners were changed. How can the name of another co-convener be added. Dr. Vikas Agashe said that the convener is free to choose his co-convener. ## 6. PROPOSAL FOR A LIVING LEGACY LIST

A Proposal for a 'Living Legacy List' was put forth by Dr. Harshad Argekar. He said that it was thanks to generous donation from two Past Presidents Donations, that we can increase the prize money awarded to the Masalawala Best Paper, Best Poster and Young and Veteran Surgeons. Similarly, he proposed to accept voluntary contributions not less than Rs. 50,000/- from its members and their names be acknowledged by publishing their names in the annual report. He said that this amount will not be tax deductible. Dr. Aseem Parekh said that the list be written as 'In grateful Appreciation' and their names be published in the book of Legends. Ingalthalikar agreed to donate Rs. 1,00,000/- each. Dr. Harshad Argekar thanked the President, Secretary, EC Members, Dr. A. J. Thakur, Dr. Sandeep Sonone, and Mr. Vaibhav Pisal. ## MINUTES OF THE ANNUAL GENERAL BODY MEETING OF THE BOMBAY ORTHOPAEDIC SOCIETY HELD ON 26<sup>TH</sup> FEBRUARY, 2023



Letter from Dr. A. J. Thakur received. The Good Practices book will be updated and followed.

Dr. Rajesh Gandhi said that there needs to be a compulsion of some sort on EC members attending the clinical meetings. Dr. Walawalkar said that a leave of absence may be given. Dr. Sushil Sabnis said that the clinical meetings should be attended. Dr. Roshan Wade said that the attendance of EC members for all clinical meetings should be printed in the Annual Report. Rule of attendance for EC meetings is established, same can be extra polated to clinical meetings. Dr. A. J. Thakur said that it is a matter of honour to be elected as EC member. Hence, we should not force them to attend meetings. It should be voluntary. Dr. Pradip Nemade said that if EC members are not attending the meetings, introspect the content of the meeting. If it is good and relevant, people will attend. Do not force people to attend. Dr. Harshad Argekar agreed. Dr. Sandeep Biraris said that then the attendance will be made compulsory for not clinical meetings only. But to Master Series as well. Hence, should not force attendance. Dr. Vikas Agashe said that the EC members are meant for the running of the society. Do not print attendance and insult EC members. Dr. Roshan Wade said that the 2nd year EC members be given responsibility of Clinical Meetings.

- Dr. Swapnil M. Keny letter was discussed

Dr. Swapnil M. Keny proposed that BOS should apply to IOA as a separate chapter of IOA.

Dr. H. R. Jhunjhunwala said that BOS should apply again to President, IOA with all the activities of BOS. Dr. Sushil Sabnis said that BOS cannot apply as only state chapters can apply. Dr. Vikas Agashe said that all these documents were already sent to IOA. It was agreed upon by Dr. Ramarao that BOS cannot become a city chapter of MOA and BOS will be an independent chapter. However, these papers were lost. Dr. L. N. Vora and Dr. Ram Prabhoo had agreed that BOS will be chapter of MOA but BOS will not share any profits with MOA and the BOS autonomy will be safeguarded. Dr. Mohan Desai said that since BOS hosts the Western India Conference, it cannot be a city chapter. Dr. Pradip Nemade said that if we apply to IOA, are we ready to relinquish our independence and become a chapter of MOA? As then we will have to follow MOA guidelines. Dr. Rajesh Gandhi said that there is no documentary evidence that BOS is a district chapter of MOA. We should limit our discussion to should BOS apply to IOA. Dr. Sangeet Gawhale requested Dr. Ram Chaddha to clarify. Dr. Harshad Argekar said that we can apply but the IOA will decide as per their constitution. Dr. Swapnil M. Keny said that we can apply as Zonal Bodies to IOA. Dr. Neeraj Bijlani said that the IOA constitutional amendment states that the 'IOA may cooperate with global, international, national, regional, subspeciality association'. Hence, we can apply under these. Dr. Ram Chaddha said that BOS should do what we feel appropriate, let the IOA decide what IOA needs to do. So, we can apply and wait for the IOA reply. Dr. Vikas Agashe said that IOA will reply as per its constitution. Dr. Ram Chaddha said that we can apply under the 'Regional' category and wait for their reply. Dr. Abhijit Kale said that Bombay was named after the Bombay Presidency in 1961. BOS was formed before the MOA. Like the Ranji cricket which has both Mumbai and Maharashtra teams. So, we can have two separate IOA chapters. A committee can be formed to pursue this issue. Dr. Walawalkar said that BOS should not apply as it is already a very well recognized society and does not need an IOA affiliation. Dr. Sandeep Biraris said that IOA considers state chapters. So BOS members elsewhere will also be accounted a respective state chapter members. Dr. Roshan Wade said that BOS should not apply, as BOS is a brand. This application will lead to bitterness between BOS and MOA. Also, the name Bombay should not be changed. Dr. Pradip Nemade said that the image of both bodies is different - IOA and BOS. BOS is looked upon as an academic body. Hence, we should not apply. Dr. Vikas Agashe said that we are misinterpreting 'Regional'. IOA already has 4 recognised regions and one pending. Hence, he suggested we should not apply. Dr. Rujuta Mehta asked what would be the financial implications of the application to IOA. Dr. Neeraj Bijlani said that there would be none. BOS would be need to just submit minutes of the meeting and BOS need stop host the IOA president. No need to submit any financial documents. BOS at present is an affiliate district chapter of IOA. Dr. Roshan Wade said that we also need to consider that BOS has

already won the bid to host IOACON thrice earlier. Dr. Neeraj Bijlani said that IOA awarded the IOACON to BOS twice once in 1980 and once in 2005 and only once to MOA in 2020. Dr. Roshan Wade said that this is a major point and has to be debated as a separate agenda, not in 'any other matters'. Dr. Walawalkar too agreed to the same. Dr. Sangeet Gawhale said that as BOS has conducted 59 WIROC conferences and 2 IOACON's the merit of BOS is proven.

The motion of BOS should apply to IOA as a separate chapter was passed by a majority vote in the AGM 30 for v/s 26 against.

Dr. Vikas Agashe said that there is no meaning to voting as we do not know if there is a suitable category to apply under. Dr. Roshan Wade said that we need to find out if BOS is a part of MOA. If yes, then automatically we cannot apply. Dr. Pradip Nemade said that this should have been a part of the main Agenda. Dr. Neeraj Bijlani said that this was presented in the EC meeting, where Dr. Pradip Nemade did not object. Dr. Rujuta Mehta said that the Voting has already been done, any further discussion should be emailed, not discussed now.

Dr. Ram Chaddha said that since there are only two halls at WIROC 2023, we can consider a mid-year smaller WIROC. Also, since WIROC 2025 is the Diamond Jubilee year, something big may be planned to mark the year.
