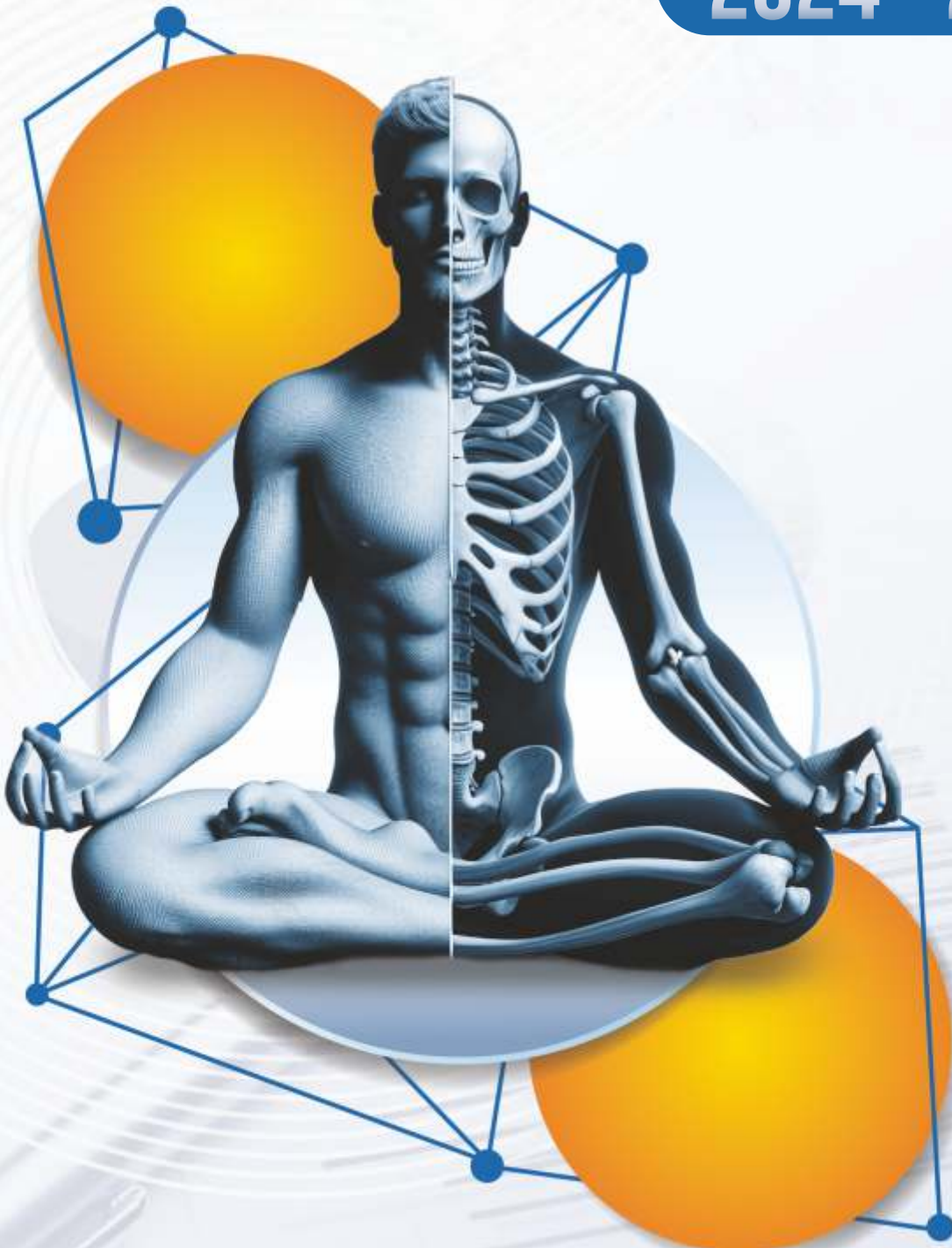





NOTICE FOR THE ANNUAL ELECTION OF BOMBAY ORTHOPAEDIC SOCIETY

Elections for the following posts in Executive Council will be held during the Annual General Meeting (AGM) of the Bombay Orthopaedic Society (BOS) on **Sunday, March 16, 2025 at Meeting Room No. 206 A & B, Jio World Convention Centre, BKC, Mumbai.**

- **PRESIDENT ELECT: 1 Post - Vacant**
(1-year term; Dr. Mohan Desai will be Immediate Past President from April 1, 2025 and Dr. Gautam Zaveri takes over as President on April 1, 2025)
- **VICE-PRESIDENT: 1 Post - Vacant**
(1-year term; Dr. Samir Dalvie completes his term and is not eligible for re-election)
- **HON. TREASURER: 1 Post - Vacant**
(2 years term (2025-2027); Dr. Satish Mutha completes his term and is not eligible for re-election)
- **MEMBERS OF EXECUTIVE COUNCIL: 2 Posts - Vacant**
(3-year term; Dr. Dhiraj Sonawane & Dr. Anoop Dhamangaonkar retire after completing 3 years in the Council and are not eligible for re-election)

Members desirous of contesting the election to these posts should complete a nomination form and return it to the Hon. Secretary, at the Society's Office on or before 5.00 pm on 15th February, 2025.

A member may apply for only ONE post.

A copy of the nomination form may be obtained from BOS office.

Last date to withdraw nomination is February 22, 2025 by 5.00 pm.

Emailed nomination forms or Digital format will NOT be accepted. BOS does not take the responsibility for any postal/courier delays. In the event that the number of applying candidates is same as the number of vacant posts, there will be no election.

The candidates are expected to adhere to a high moral code of conduct.

Executive Council has appointed Dr. Sanjay Dhar as The Chief Election Officer

All applications will be scrutinized by him in consultation with the President and the Secretary. Other rules governing the election process are mentioned below.

ELIGIBILITY CRITERIA FOR ABOVE POSTS AS PER BOS CONSTITUTION

All Members other than Overseas Members, in other words Life Members and only those with at least 5 years standing as a Member. The office bearers and members of the council shall only be those, whose addresses are registered with the office of the BOS as residents of Mumbai, Thane or New Mumbai region.

President-Elect: A candidate should be a member of BOS for a minimum period of 10 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

Vice-President: A candidate should be a member of BOS for a minimum period of 7 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.


Hon. Treasurer: A candidate should be a member of BOS for a minimum period of 5 years. Further, he should have served the BOS as an Executive Council Member for a minimum period of 3 years.

Executive Council Member: A candidate should be a member of BOS for a minimum period of 5 years. No previous experience as Executive Council Member is required.

NOTICE FOR THE ANNUAL ELECTION OF BOMBAY ORTHOPAEDIC SOCIETY

- Executive Council has appointed Dr. Sanjay Dhar as the Chief Election Officer.

- **Election process will start at 10.30 am during the AGM. The process will be concluded at 12.30 pm. Any member not in the voting queue by 12.30 pm will not be allowed to cast his or her vote.**
- The candidate or his (one) representative may be present during the counting process.
- Disputes, if any will be considered by a Council (President, Secretary and the Chief Election officer) and their decision is final and binding.

There was a six-week BOS arthroplasty fellowship, newly introduced & started at KEM Hospital, offered an unparalleled opportunity for the candidate to observe cutting-edge robotic surgeries, including knee replacements, complex primary and revision hip and knee replacements, and reverse shoulder procedures. The fellow was also privileged to participate in the groundbreaking RIO Workshop - Robotics and Intelligence in Orthopaedics Certification Course. The applications were invited for selection of the fellow from the members of BOS. The applications were scrutinised on the merits by the subcommittee constituted by the BOS Executive Council & Dr. Ankit Waghela was awarded this fellowship.

RIO workshop was a first-of-its-kind event, featuring the Cuvis and Velys robotic systems with hands-on cadaveric training. Every cadaver was meticulously scanned using CT technology, with data fed into CT-guided robots to ensure precision. Held between KEM Hospital and HN Hospital, this course set a benchmark in advanced orthopaedic training. Importantly, the BOS Arthroplasty Fellow attended this prestigious course entirely free of cost as part of a complimentary package - a testament to our commitment to nurturing the next generation of orthopaedic leaders.

Dr. L. N. Vora Master Cares & Master Shares is the program on alternate month, first Sunday started by our Ex-President Dr. Nicholas Antao. It has also become a flagship event of the society. Yearlong series of 6 such courses were very well crafted by our dear Vice President Dr. Samir Dalvie. These were well attended & appreciated by the members.

Clinical meetings are similarly the flagship event of BOS. They were at 6 different venues.

All these had MMC accreditation points.

WIROC 2024 was an astounding success, and it fills me with immense pride to reflect on what we achieved together. This year, we deliberately chose a venue steeped in nostalgia and significance - the very location where WIROC 2015 celebrated its golden jubilee.

As we enter the 60th year of the Bombay Orthopaedic Society, it is a time to celebrate our legacy, acknowledge our achievements, and look forward to a future brimming with possibilities. This milestone is a testament to the dedication, vision, and values of every member who has contributed to our journey.

These words encapsulate the spirit of our Society. For six decades, the seeds of knowledge, ethics, and collaboration sown by our predecessors have flourished into a vibrant community that continues to inspire and innovate.

As custodians of this rich legacy, it is our responsibility to nurture it further, ensuring that the shade of this great institution continues to provide academic excellence, ethical guidance, and camaraderie to the generations that follow.

Reflecting on the past year, it has been a period filled with dynamic clinical activity and steadfast dedication.

Our clinical meetings in leading teaching hospitals - KEM Hospital, Jupiter Hospital, LTMMC Sion Hospital, MGM Medical College, and JJ Hospital - were well-attended. However, the feedback on dwindling attendance of surgeons from neighbouring areas highlights the need to revamp our approach to maintain interest and relevance. In an era where academic content is easily accessible online, our challenge lies in reflecting reinventing innovating and engaging effectively.

This year, the **Dr. L. N. Vora Master Shares and Master Cares series**, convened by our Vice President Dr. Samir Dalvie, stood out for its thought-provoking theme, "Do It Right," which focused on techniques for better outcomes in common orthopedic problems. The inclusion of speakers from allied specialties enriched the discussions, providing a comprehensive perspective. The overwhelming response to these programs reaffirms the importance of such initiatives.

Our flagship events continue to draw significant interest. With over 750 educational videos on our YouTube channel and nearly 3,700 subscribers, we have expanded our social media presence, including Instagram, and leveraged WhatsApp to share academic programs and updates.

We are also streamlining flagship courses in trauma, arthroplasty, arthroscopy, spine, and pediatric orthopedics, while building a case bank of standard cases to serve as a valuable resource for course conveners.

The academic year saw the successful completion of 17 teaching courses, including basic and advanced specialty courses. Popular courses such as the basic and advanced arthroplasty courses, basic arthroscopy course, spine course, pediatric orthopedics course, and hand course deserve a special mention for the efforts put in by their conveners and teams.

By combining certain courses, we optimized the use of cadavers and economized this for the delegates. Encouraged by the success, we aim to conduct more cadaver workshops in private hospitals in Navi Mumbai along with our colleges in Mumbai.

FROM THE DESK OF HON. SECRETARY

This year, the **BOS Robotic Arthroplasty Fellowship** was launched, selecting Dr. Ankit Vaghela from a pool of 25 applicants for a six-week observership at KEM Hospital under the mentorship of Dr. Mohan Desai. The Positive feedback has motivated us to extend similar fellowships to spine and pediatric orthopedics next year, broadening our academic initiatives.

We conducted four outreach programs, including one in Navi Mumbai, two in Mira Road and Bhayander, and a forthcoming collaboration with the Thane Orthopaedic Association in March 2025. Additionally, affiliate programs were held with the Musculoskeletal Oncology Society and Tata Memorial Hospital on giant cell tumors and with Khar Hinduja Hospital on lumbar disc prolapse. These collaborations reflect our commitment to expanding our academic reach.

Our flagship event, **WIROC 2024**, organized by Dr. Anoop Dhamangaonkar, Dr. Dhiraj Sonawane, and Dr. Mohan Desai, was a resounding success, with record attendance and engaging sessions. The academic and entertainment balance was a testament to meticulous planning and execution. The BOS Student of the Year and Rising Star competitions showcased exceptional talent, with Dr. Vikrant Mahajani and Dr. Taarini Johri winning top honors, respectively.

As we mark the 60th year of our society, we have resumed the publication of our newsletter, Cadence, to capture and celebrate the contributions of our members.

This year, we mourned the loss of some of our colleagues. Most notably, **Dr. K. V. Chaubal**, one of our founding fathers and a beacon of academic excellence, high integrity, and moral values. Dr. Chaubal continues to inspire us through his teachings, which live on through his students and their students.

It is these giants on whose shoulders we stand today, enabling us to move forward with resolve, deep gratitude, and an enduring commitment to their values and teachings.


This quote very rightly describes what the past Presidents of our society have handed down to us to take care and our current president and his team embodied the same.

GUIDELINES FOR BOS COURSE CONVENERS

ACADEMIC/ADMINISTRATIVE

1. Conducting a BOS course should be a privilege and all attempts should be made to uphold the reputation of BOS as an academic body while conducting these courses. The academic content and the faculty should be of the highest standard. The BOS Courses have been looked upon very favourably for the past 60 years and every convener should try and better the course content and delivery.
2. In keeping with the developments in various specialities of orthopaedics changing paradigms and concepts we understand the need to evolve and experiment with conduct of the course and delivery, we would like the conveners to share the ideas with the EC by the 15th of March 2025 upon allocation of the course or you may wish to do so at the time of application to support your case.
3. On allotment of the course the tentative program and the proposed faculty must be submitted to the Executive Council by the 15th of March 2025.
4. We encourage conveners to include faculty who are BOS Members and who will be able to give due commitments for the duration of the course. The BOS has some stellar faculty, steps must be taken to utilise them completely. Newer faculty may be introduced as table instructors or faculty in small group discussions with senior mentors.
5. The course content should be scientific relevant to the course and the experience of the delegates and based on evidence. Convener should ensure their faculty refrain from using eminence based or anecdotal examples.
6. The course should have a good mix of theory-based talks and lectures surgical case-based discussions and interaction with faculty in different hospitals in the form of surgeon visitations. The convener may approach the EC for help suggest centres and consultants for surgeon visitations, however the necessary permissions and formalities for surgeon visitation must be done before the course commences. Pre planning of the visitations will help the delegates in planning their stay and movement throughout the course.
7. If cadaver dissection is planned then liaising with the EC and other course conveners may help us stream line the courses their dates and explore the possibility of economising the expenses on the cadaver lab.
8. Industry participation may be encouraged for accessing instrument sets and sawbones. Due credit will be given to them where applicable.
9. Please plan the finances and logistics well as we want to ensure a smooth course without any burden to the convener or the BOS.
10. Certificate of participation signed by Convenor, President and Secretary as per the set format of BOS. If course accredited by MMC, MMC Observer sign will be required.
11. On the course banner, only the following names can be printed: Convenor, President and Secretary as per the set format of BOS. Any promotion of the course on social media must have aegis of BOS course written prominently.
12. It is preferable that application to MMC for Accreditation points to be done by Convener, if you need help from BOS Office, please obtain prior permission of the BOS Secretary to do so. It shall be the responsibility of the Convener to upload the attendance and comply with all the MMC requirements. Upload attendance within one week of completion of the course.
13. Please furnish a report of the course along with the bills within 15 days of completion of the course and a detailed report of the attendance and Delegate feedback. For the courses which are being held in November and December, the report to be submitted latest in 15 days after the course is over or by 15th December, whichever is earlier for publication in the annual report.

14. Selected candidates must be intimated timely as regards their selection and timings of the course, so that they can make their travel plans well in advance.
15. All due permissions from higher authorities in the respective institutions through HOD Orthopaedics and other allied departments, Dean permissions must be taken 2 months in advance, auditorium bookings etc. must be ensured to avoid last minute cancellations and embarrassment to BOS.
16. Courses, who do not receive at least 50 percent of applications 15 days prior to the event, may be scrapped if not viable. Due efforts must be made to popularise and advertise the courses if it is known prior that there are not enough applicants. At least one month prior to the event, the course quorum must be complete.
17. The convener may refer to a Case bank for taking clinical cases for discussion and acknowledge the source. He may also contribute to the faculty support packages by giving some of the PowerPoint slides of cases, PPTs of lectures as PDFs or handouts to the Secretary BOS for reference and use in the following years.
18. If a delegate is absent for the full course, you are expected to intimate the same immediately to BOS Office.
19. Bombay Orthopaedic Society is not responsible for any ill health or hospitalisation of delegates during the course, or any travel reimbursement of the same.
20. Please maintain good and efficient communication throughout the course with your delegates. You may add the BOS Secretary and Treasurer if forming a WhatsApp group. However, it is not acceptable to submit bills on WhatsApp. Physical copies are to be delivered to the Secretariat or scanned copies on e-mail with a detailed covering letter. BOS Office will not arrange for the collection of the same.
21. Feedback forms must be submitted online only. After verification of which the certificates will be issued to the delegates.
22. Delegates must be encouraged to be BOS Members and also encouraged to use the BOS Protocols App

COLLECTION AND DISBURSING OF FUNDS FOR BOMBAY ORTHOPAEDIC SOCIETY COURSES

1. The course fees should be in moderation. There is a GST of 18% on the course fees. There is a quantum of administrative charges, staff, banners, certificates, feedback, emailer and mass SMS (only 3 per course allowed). As a rough estimate, 25% of the course fees should be kept aside for above reasons and only balance 100 - 43 (18+25) 60 percent be spent. Amount Exceeding 60% of the collected revenue will not be sanctioned by the Executive Council under ANY circumstances.
2. It is desirable for the course to make a profit of at least 15% of the gross collection. Spending on faculty welfare is not allowed. Gifts to the faculty are NOT allowed. No mementos will be given to any faculty member during the course. Thank you letters to participating faculty as a courtesy must be arranged within 48 hours of the event.
3. The budget should be submitted before declaring as awarded in GBM; GBM should have only the list of decided courses with breakup of what the expenses are for. Any convener exceeding budget for 2-3 consecutive courses should be barred/fined.
4. BOS will not pay for instruments for any course as per AGM mandate. If instruments are taken on BOS name as a donation, prior intimation to the Secretary and Treasurer is mandatory. They need to be deposited at the end of the course within a week with a detailed list with the Treasurer, with an accompanying covering letter by the respective company.
5. Course dinner is not essential part of whole show. If planning it, make sure you are able to manage it within the budget allocated. Payment for catering bills should not be made in cash and Society is willing to issue a cheque in advance; money may also be paid by individual's credit card and Society will reimburse him by issuing a cheque. Personal Cheques and Credit Cards are acceptable mode - reimbursement by the Society is easy. For amounts more than Rs. 1,00,000/-, PAN card number of the payee is essential.
6. All sponsors must make their contribution to BOS; Sponsors of a BOS event should not give money directly to a Convener. It must come to Society's account and then spent for specified event. Sponsors are not expected to display their commercial visuals, banners etc. inside a meeting hall; all displays should be outside the meeting hall.

7. Payment in cash for bills higher than Rs. 30,000/- will not be allowed by the Executive Council as the Society cannot claim it as expenses. As internal policy, BOS wants to minimize spending in cash; such expense should only be for tips, and for small expenses lesser than Rs. 2,000/-.
8. If you need to pay any advance for conducting the course, please feel free to contact the Secretary or Treasurer at least 15 days prior to conducting course, we will make the arrangement for the same.
9. Please keep the expenditure within the total amount of course fees. If for some reasons you are likely to shoot the budget, you are requested to take prior permission from the BOS EC for the extra expenditure. Let the EC ratify / grant permission for the extra expenditure and then only go ahead with the same. For any special requirement, please submit prior quotation and justification and get it approved by the Secretary / Treasurer.
10. BOS will not pay rental charges to private clinics for the conduct of a course, implants for the patient, anaesthesia charges or consumables for the same.

FLAGSHIP EVENTS OF BOS

1. a) **JCT Memorial PG Clinics:** Voucher payments for basic tea, coffee and refreshments will need the bill to Bombay Orthopaedic Society written clearly. Any other sundry minor expenses may be sanctioned with prior intimation to the BOS. If organising a lecture series, standard MMC application rules will apply.
2. b) **Clinical and Master Series meetings**
 1. The present expense limit for such events is Rs. 35,000/-. Part sum may be given in advance to the Convener in cash; as internal policy, BOS Wants to minimize spending in cash; such expense should only be for tips, and for small expenses lesser than Rs. 2,000/-. All food bills for various meets and courses should be paid by cheque; all caterers connected with Medical College canteens have PAN cards and can take cheques. Money can also be paid by individual's credit card and Society can reimburse him by issuing a cheque.
 2. All Clinical Meetings, Master Series and Course Conveners are expected to submit their accounts within 15 days of completion of their events along with the Convener's report. All such bills are checked and settled if found in order within 3 weeks of submission to Society's office. EC will take a serious note of late submission of expense sheet and course report; this may be taken against a Convener for future activities.
 3. Any payment made on behalf of BOS must be supported by an invoice (bill); for small amounts paid in cash it must be supported by a voucher signed by the concerned person. All bills must be collated and countersigned (approved) by the concerned conveners. Vendors are discouraged to submit the bills to Society's office. All these bills are seen and approved (signed in red) by the Hon. Treasurer before a cheque could be released. All cash expense vouchers should be countersigned by the Hon. Treasurer.
 4. Please furnish all the bills together bearing your signature after the course, so that payment can be done immediately at one instance. Please see that the payment is made by cheques as far as possible. Preferably 80% to 90% of payment should be done by Cheques. All expenses to be supported by bills and vouchers.

I would like to report with great pleasure about the successful completion of the BOS "Advanced Paediatric Orthopaedic Course, 2024 (Paediatric and Adolescent deformity correction course)". This year, we could have one of the highest number of delegates, (16) from all parts of the country as well as one international delegate. We were in fact over-subscribed and had to refuse a number of subsequent queries for registration. This year, the theme of the advanced course was Paediatric and adolescent deformity correction and we could provide the delegates an in-depth curriculum to understand most of the aspects of this difficult sub-speciality. The delegates ranged from just post MS to almost 30 years in clinical practice. The course lecture started off with a masterclass on planning of deformity correction by Dr. Mangal Parihar and team followed by lectures on basics of deformity correction. Cadaveric dissection session was held in the afternoon at the state-of-the-art Anatomy dissection hall at MGM Hospital coordinated by Dr. Rahul Kadam and Dr. Deepak Jain. The next 2 days were at BJ Wadia Hospital (coordinated by Dr. Rujuta Mehta and Dr. Alaric Aroojis) and Agashe Hospital, Kurla where we were able to show 10 complex operative case demonstrations over the course of these 2 days as well as have various lecture series on pre-operative planning. Day 3 concluded with lectures as well as saw bone and 3D printed model demonstrations by Dr. Sandeep Vaidya and Dr. Taral Nagda as well as lectures by other faculties. The high quality of audiovisual transmission of surgeries ensured that the delegates were glued to the seats till the end and could note each and every small detail of the surgical procedure demonstrated. The three-day BOS Advanced Arthroplasty Course was held on September 27-29, 2024 at Lokmanya Tilak Municipal Medical College, Sion, Mumbai. Various teaching modules were included in the course to impart knowledge in field of Hip & Knee Arthroplasty.

The theme for 1st day was advances in primary complex THR & revision THR. Eight concepts based talks along with 3 Inbox surgeries including Robotic THR surgery (recorded and edited) were relayed. A breakout session was held where 2 Joint Masters interacted with 7 delegates (2:7 ratio, 58 delegates in total) to answer and solve their queries in one-on-one basis. Two sessions of case based panel discussion were held during which cases were discussed with interaction from delegates to help them develop a thought process of analysing and pre-op planning a particular case which would be helpful in their daily clinical practise. The theme for 2nd day was advances in primary complex TKR & Revision TKR. On this day, 4 Inbox surgeries were relayed to explain important surgical steps in complex scenarios. Nine concept based talks were delivered along with 2 sawbone workshops. 2 sessions of case-based panel discussions were also held.

The theme for 3rd day was newer technologies in Arthroplasty. 3D printing, Custom made implants along with Robotic technology in arthroplasty was discussed at length along with relay of two Inbox surgeries. The icing on the cake was Robotic TKR Cadaveric Workshop where delegates got 1st hand feel of the Robotic technology in TKR along with different approaches for Hip Arthroplasty.

Overview: The BOS Basic Fracture Fixation Course 2024 was conducted from October 17 to October 19, 2024, across three prestigious locations: Apollo Hospital, Dr. D. Y. Patil School of Medicine, and Fortis Hospital, all in Navi Mumbai. The course was meticulously designed to provide an in-depth understanding of the principles and current practices in fracture fixation.

Target Audience: Post graduate students and recently certified orthopaedic surgeons

2. To read and confirm the Minutes of the AGM held on 26th February 2023: The AGM minutes were passed without any changes; Proposed by Dr. Rajesh Gandhi and Seconded by Dr. Gautam Zaveri.

3. Presidential Address by Dr. Sanjay Dhar: He highlighted about the programs introduced by him; "Student of the Year" and he expressed gratitude for all the teaching institutes and their Department Heads which participated in this program and supported this program. He also proposed that felicitation / expression of gratitude could be done for them.

Second program was "BOS Rising Star" for the young orthopedic surgeons and he expressed his gratitude to OrthoTV, Dr. Ashok Shyam for the success and support for this program.

He thanked the Organizing Secretaries, Dr. Pradip Nemade and Dr. Sandeep Biraris for supporting all Presidential activities and WIROC 2023. He also extended his gratitude to the entire Executive Council.

Dr. Sanjay Dhar mentioned that Bombay Orthopaedic Society is an efficient society in terms of academic activities, various clinical programs over the year and providing networking opportunities during WIROC and other clinical meetings.

He proposed that BOS should have a unique and a well-modulated Basic Fracture course wherein the pattern / objectives remains same which people would aspire to attend.

Mentorship program: Something like a 1-year fellowship program in sub-specialities and these could be paid fellowship which will make a life changing difference in their career.

Lastly, he emphasised about Research collaboration and reviving the Journal of Clinical Orthopaedics, Diversity and inclusion initiatives; Outreach Programs from other societies MBOS, NMOA and also, we must invite State associations and Technology Integration and amalgamation with public outreach and Education and continuous evaluation and improvement.

4. Presentation of Hon Secretary's Report: Dr. Neeraj Bijlani presented the Secretary's report about the academic activities - 6 Clinical Meetings and 6 Master Series and almost 100 plus attendees for each of them. Comments from general body was invited for the clinical meetings.

Dr. Rajesh Gandhi mentioned that this academic year has been a wonderful year and congratulated the President and BOS for the same. He proposed about the course fees, that the course fees should be regulated in a way that an amount should be supported by BOS and if any also in cases if the course exceeds the expenses. We should have a standardization of courses format but it should not conflict with the convenors ideas but there should be some fixed guidelines and it might take some time to implement these, and a collective responsibility should be taken to standardize the courses to add relevance to our academic activities. Dr. Sanjay Dhar added that 1 Marquee course should be standardised and rest can be planned by the convenors.

Dr. Mohan Desai added that a syllabus for a course should be formulated, and the guidelines should be given to convenor and accordingly the course can be planned.

Dr. Neeraj Bijlani informed the house about the EC discussion that BOS Member / PG student should be

given 50% discount for all Basic Courses. BOS can also support an extra 30% for conducting the course and an amount of maximum 1 lakh and it will be only applicable for 5 Basic courses (Trauma, Spine, Paediatric, Arthroplasty, Arthroscopy) and if this works well this academic year and it could be continued.

Dr. Anil Karkhanis emphasized that a take home message should be clear at the end of the course.

Dr. Shubhranshu Mohanty suggested that all course reports should include the course feedback in the course report so as to it works as a guideline for the next convenor.

Dr. Pradip Nemade expressed that courses when collaboration with other society could create conflicts of interest in terms of agenda and we could keep it purely a BOS activity as the success of BOS courses is mainly because of the BOS faculty and Dr. Sanjay Dhar mentioned that he had suggested the collaboration with other societies is only for WIROC and not for courses.

Dr. Rohan Gala said that the feedback should not be printed and instead it can be confidential or shared with EC / BOS Secretary.

Dr. Sangeet Gawhale and Dr. Sandeep Biraris said that every EC meeting should have an agenda wherein the course feedback should be discussed and not printed in the annual report and passed to the next convenor.

Dr. Charan Jadhav said that outreach meetings should be conducted in MBOS. Dr. Mohan Desai mentioned that it will be done.

The Secretary's report was proposed by Dr. Shubhranshu Mohanty and Seconded by Dr. Harshad Argekar.

5. The Hon. Treasurer's Report was presented by Dr. Satish Mutha and post circulation no suggestions were received so it is assumed that it was acceptable to all. There has been a robust growth in 2022-2023 due to astounding success of last 2 WIROCs and BOS courses, Clinical Meetings and Master Series are not fully sponsored.

Last year, 2 donations were received from Dr. Ram Prabhoo and Dr. V. T. Ingalhalikar with gratitude.

He thanked last WIROC 2023 organising team for the profit and he continued that the corpus should be utilized for fellowships as suggested by Dr. Sanjay Dhar.

Dr. Sangeet Gawhale enquired if the past recovery from Pharma companies was recovered or not? To which Dr. Satish Mutha replied that yes, it was done. Also, Dr. Sangeet Gawhale enquired how would the profit be divided among the Fixed deposit and is there a problem about the signatories. Dr. Satish Mutha explained that now its streamlined and Bank of Baroda and Bank of Maharashtra have accounts and signatories have the authority.

The treasurer's report was proposed by Dr. Anil Karkhanis and Seconded by Dr. Sangeet Gawhale.

6. Proposal to continue the programs which have been started by the GBM, should be continued for 5 years. Dr. Sanjay Dhar mentioned that if at all needed to stop should be done by General body.

Dr. Harshad Argekar presented about the BOS protocol app, it is currently functional on Android Play store and IOS. This app can enable customized patient specific documented informed consent which can be shared with patient and the treating Doctor. This creates an authentic legalized document which is shared with the patient on whatsapp / email. He has urged the GB to download the app and use it and he has welcomed more suggestions which can be incorporated.

Dr. Rajesh Gandhi announced the election process to be started at 10:30 am and explained the rules and election process.

To continue with point no. 6, Dr. Rajan Walawalkar asked if choice of language is available and should it be read out to the patient.

Dr. Shubhranshu Mohanty enquired how will it be ensured that the patient have read it, so Dr. Sanjay Dhar explained that it is a documentation of the conversation which is done prior to the surgery in OPD and it is explained that taking a print out and taking patients signature could help it.

Dr. Neeraj Bijlani and Dr. Sanjay Dhar explained that this is early version and will be upgraded very often and will continue for 5 years until the AGM decided its fate.

Dr. Rohan Wade said that will this app owe any Medicolegal liability to the Bombay Orthopaedic Society. This was explained by Dr. Sanjay Dhar and Dr. Harshad Argekar that BOS is just giving guidelines and not liable for any medicolegal purpose. Also, he enquired about the data sharing of patient which was explained that patient details are optional.

Dr. Ram Chaddha said that at the end of the consent a comment box should be provided so that it can have a patient specific and some particular / surgery specific comments. It was agreed by and will be incorporated in next version.

Dr. Anil Karkhanis enquired that can more documents (OT notes, progress notes) be included which will help during tribunal trials. Dr. Mohan Desai said that it is part of Hospital management software and BOS cannot do it as it is hospital specific. Dr. Harshad Argekar mentioned that this is app is not a management software, but just an explanation of surgeries and informed consent about all the complications and the app cannot take responsibility of saving data.

Dr. Pradip Nemade enquired if personal data or information is it safe? Where is the data saved? And is website mentioned on the app (BOSOrthoProtocolApp.com) is it official BOS Ortho website? Dr. Harshad Argekar said that data is managed and saved on Amazon Web services and Cloud and any individual is not liable for saving the data, the data is safe and amazon has encryption and safety guidelines which they do for sites all over the world the administration manages the email for the app.

Dr. Dhiraj Sonawane enquired if a Desktop version is possible. And if a video consent is possible? The suggestions are taken and will be incorporated.

Again, the security aspect was questioned about hacking and its safe and secure just like other apps managed by Amazon web services. And medicolegally BOS is not liable as it is equivalent to downloading a consent downloaded from NHS / AAOS and its just providing a format for the consent and about giving the information to patient.

Dr. Roshan Wade enquired what was the need to make this app? Did anyone request for it? So, Dr. Neeraj Bijlani mentioned that as it was BOS Presidential theme for 2017: Perfection through protocols and the book was circulated in WIROC 2017 and now it's just converted in an app - for ease of use. Also, that it is a trial project and it's one's personal choice to use it.

Dr. Vikas Agashe congratulated Dr. Harshad Argekar for the same.

Dr. Sangeet Gawhale, Dr. Ram Prabhoo and Dr. Vikas Agashe – 3 Past Presidents have proposed and recommended, and this point should not be brought up again.

All programs, Student of the Year and BOS Rising Star and BOS Protocols have been proposed by Dr. Ram Prabhoo and seconded by Dr. Sangeet Gawhale.

7. To discuss to approve Associate Memberships to PG students in 2 installments: 1st at the time of application and Full membership after completion of MS with submission of 2nd instalment and degree certificate should be given, they will have all rights other than attending a GBM and voting.

Dr. Ram Prabhoo and Dr. Vikas Agashe mentioned certain changes said that certain restricted rights: Not conducting courses or being convenors and the courses and all rights should be mentioned. It was suggested that this is a constitutional amendment and will need an Extra Ordinary GBM for Constitutional

amendment and should be discussed in that and could be ratified next year. Proposed by Dr. Anil Karkhanis and seconded by Dr. Mandar Agashe.

8. Creating and Curating and Exhaustive Fracture Course run by an EC nominated convenor and well-defined curriculum: Dr. Gautam Zaveri suggested the BOS courses should be standardized and the convenor is honored to conduct the course and to avoid randomness, strict guidelines should be considered and that he would like to volunteer to design the course and a subcommittee - Should standardize the course 80% and 20% should be planned by convenor.

Dr. Pradip Nemade expressed his concern about less applicants for conducting the course. So, this will be applicable from this year 2024.

Passed with suggestions from Dr. Mohan Desai and Dr. Gautam Zaveri and proposed by Dr. Gautam Zaveri and seconded by Dr. Shubhranshu Mohanty.

9. Appointment for the Auditor 2024-2025: Treasurer approved the continuation of C. M. Gabhawala & Co. Proposed by and Dr. Ram Prabhoo and seconded Dr. Sangeet Gawhale.
10. Approve the dates for Clinical meetings and venue as per applications received and to declare the Dr. P. K. Mullaferoze Best Clinical Meeting award for the year 2023-2024:

All dates approved, passed and proposed by Dr. Rujuta Mehta and seconded by Dr. Mohan Desai.

For the 1st time, the Dr. P. K. Mullaferoze Award for the Best Clinical Meeting was awarded to BJ Wadia Hospital for Children and the shield was handed over by Dr. Sanjay Dhar to Dr. Rujuta Mehta.

Dr. Shubhranshu Mohanty suggested putting a photo frame of Dr. P. K. Mullaferoze in clinical meetings so that young orthopods are aware of her and her contribution.

13. Dr. R. J. Katrak Orator and Dr. K. T. Dholakia Eponymous Lecturer of WIROC 2025 were ratified by GBM as follows:

Dr. Mohan Desai was concerned about writing and telling them that they would be kept as a stand-by speaker for the proposed one. Dr. Vikas Agashe also agreed with this point. Dr. Sunil Shahane said this has been carried forward for many years and to date no one had any problems. Dr. Harshad Argekar suggested that the proposed stand-by speaker should be invited as a guest for the confirmed orator.

Dr. Sunil Shahane was concerned if the proposed orator is from abroad, he is coming as a guest for one year and as a confirmed orator next year then are we going to spend twice on his travel, and local hospitality?

Then in GBM, it has been ratified that if the guest orator wishes to come next year as a speaker then we

should bear the cost and invite him again.

This was proposed by Dr. Mohan Desai and seconded by Dr. Parag Lad.

14. WIROC 2023 report

Dr. Sandeep Biraris and Dr. Pradip Nemade presented the report of WIROC 2023. They thanked BOS EC, Dr. Mangal Parihar, academic partners MOA, NMOA, MBOS and industry partners that supported WIROC 2023 and all the Faculty and Delegates. They mentioned that they had the highest registration count of more than 1,600 this year. They handed over a cheque of Rs. 1 Crore to the BOS as Profit including GST. The report presentation was proposed by Dr. Satish Mutha and seconded by Dr. S. S. Mohanty.

15. Journal of Clinical Orthopaedics (JCO)

Dr. Sanjay Dhar suggested that we should appoint an editor for the JCO and try to make it index journal or pubmed journal.

Dr. Gautam Zaveri said there are many Indian ortho journals existing which are indexed and for JCO it will be difficult to make it pubmed indexed.

Instead of that, we should have an editor and one specific topic. It will be like symposia of one particular topic. Dr. Mohan Desai mentioned that the best paper selected for Masalawala during WIROC should be chosen to be published in JCO but Dr. Gautam Zaveri and Dr. Sangeet Gawhale argued that the author would wish to publish his best paper in a reputed international journal rather than JCO.

Dr. Arvind said we should approach DOAJ and ask their help to scrutinize papers selected for JCO. It will improve the quality of articles as well. Dr. Murali Poduval suggested that we should find a publisher and request them to help our articles getting published through their forum. The concept of symposia will become more popular if we go through publishers.

Finally, Dr. Gautam Zaveri and Dr. Sanjay Dhar said we should make a sub-committee of 4-5 people for this and initially start publishing free papers then symposia. The editor will be appointed by that committee and he will be given task and deadline to complete the job.

Dr. Neeraj Bijlani said the next issue of publication of JCO is in June 2025. So till then, the existing committee will work on this.

These were proposed by Dr. Mohan Desai and seconded by Dr. Sandeep Biraris.

16. Ortho TV to be appointed as Media Partner with BOS for 5 years.

Dr. Ashok Shyam gave a presentation about OrthoTV and mentioned the benefits of their services to BOS without having any financial liability to BOS.

Dr. Rajesh Gandhi said OrthoTV has supported BOS since so many years without any financial expectations and doing the job so well. We can have our media Chanel also update BOS activities but let OrthoTV be our media partner.

Dr. Ashish Phadnis asked Dr. Neeraj Bijlani and Dr. Ashok Shyam whether OrthoTV will help us with the hybrid program and they suggested that they can do it.

Dr. Harshad Argekar also supported Dr. Gandhi's views.

Dr. Pradip Nemade asked whether is there any need to have a media partner.

Who supported to whom? We are a scientific data creator with great scientific content. So, in fact we should sell our content to a media partner and earn revenue out of it.

He mentioned that our liability is for our BOS members and not for other non-members who can have access to WIROCs and many academic events which are streamed on OrthoTV and accessible to many

non-BOS members as well.

Dr. Dhiraj Sonavane said Dr. Neeraj Bijlani being in EC of BOS - there is a conflict of interest.

It's free for BOS, which is decided by OrthoTV so what If in future they ask then what?

Dr. Parag Lad asked whether all WIROC conferences uploaded by OrthoTV can be locked for non-BOS members or non-registered delegates. Dr. Bijlani said it can be surely done.

Dr. Ram Chaddha said any activities have pros and cons. Anyone who doesn't want to submit his content to OrthoTV then he has the right to opt-out and do not allow to put his content.

Dr. Pradip Nemade suggested that it should be BOS TV and not ORTHO TV if OrthoTV is using BOS academic content. He proposed to be a webmaster and requested the general body to give him a chance to do it for one year without OrthoTV.

Dr. Saneesh Tuteja said we need views, and reviewers via OrthoTV. Unless we find someone better than OrthoTV, then we should continue associating with them.

Finally, Dr. Mohan Desai and Dr. Sanjay Dhar said as it is there on the agenda, then it has to go for voting and sort out the issue. Dr. Neeraj Bijlani and Dr. Ashok Shyam were requested to leave the hall before taking the vote of GBM.

The vote for whether BOS should use OrthoTV services for 5 years was announced. 32 members voted for the OrthoTV association for 5 years and 20 members voted against of this proposal. So, it was decided by the General Body that BOS will be associated with OrthoTV.

17. All the applications for memberships were approved by GBM.

18. Updates on application sent to IOA from BOS as a separate chapter.

Dr. Ram Chaddha suggested that the letter has been forwarded to the Administrator of IOA and mentioned that when the new EC committee will be formed in IOA, this matter will be discussed and they will let us know.

19. Defining the relationship for ease of functioning for the future executive council for BOS to work in association with MOA and whether BOS should participate with MOACON 2024.

Dr. Neeraj Bijlani said that MOA considers BOS as a district chapter of MOA as per earlier discussion in AGM. Dr. Sanjay Dhar asked the AGM to make one blanket rule about BOS association with MOA. This AGM should decide whether we should do affiliation with coming and near future MOACON or not do it.

Dr. Mohan Desai mentioned as BOS is older than MOA, should BOS accept that as a separate dist. chapter?

Dr. Neeraj Bijlani read out the 2010 BOS AGM minutes of the meeting in which it was mentioned that BOS became MOA district chapter only for Dr. AK Gupta Trophy and there will be non-financial liability and autonomy of BOS should not be disturbed. These minutes were proposed by Dr. Vikas Agashe and seconded by Dr. A. J. Thakur. But Dr. Rujuta Mehta said it was discussed that we will be affiliating as a dist. chapter and not fully associated and this was only for Dr. A. K. Gupta trophy and nothing else.

Dr. Rujuta Mehta wanted to minute following matter in record of BOS AGM of 2024. The MOA Secretary said if Dr. Rujuta Mehta does any orthopaedic activities in Maharashtra involving all females then they must put MOA logo. She felt like It was like bullying. She said she would not promise that to MOA as the activities were initiated by IOA and not MOA.

Dr. Sangeet Gawhale was concerned that if MOA is in affiliation with BOS as dist. Chapter, then BOS is officially liable for profit sharing and many matters. Is BOS going to do it?

BOS has more life members than many orthopaedic organisations - We do have a say for applying for

separate chapters in IOA and we do not need any affiliation or we will decide whether we need such affiliations.

Dr. Neeraj Bijlani showed the email sent on 24/12/202 by MOA secretary mentioning that the MOA president should be invited to the BOS conference.

Dr. S. S. Mohanty said at present IOA does not have any provision of making any local organisation a city chapter. So, BOS becoming a city chapter is out of question and discussion.

Dr. Rujuta Mehta mentioned that if any affiliation wants to use the BOS logo for their conference and meeting then a formal proposal should be given to BOS EC and as per rules, BOS EC will decide.

Dr. Neeraj Bijlani put up one rule mentioned in the IOA constitution that IOA mandates to conduct conferences in city only if MOA has done its annual conference two times in that city.

Dr. Walawalakar suggested BOS should not have any financial liabilities with MOA.

Dr. Pradip Nemade said BOS is having an identity crisis as a dist. or city chapter but as it has members across India, it has its own identity.

Secretary / Vice President elect, Dr. Abhijeet Wahegoankar from MOA EC said he is here to make an appeal that we should work together to have a voice of reason for dialogues between BOS and MOA. We are group of highly intelligent people and we should sit together and solve these grouches.

Dr. Sunil Shahane discussed how this was started in 2008 and whether it was made clear to MOA that if BOS feels this association or affiliation is detrimental to BOS then BOS has the right to break that affiliation.

The President, Dr. Sanjay Dhar announced that there should be a voting for whether BOS should work as a district chapter for MOA. Dr. Sangeet Gawhale said there is no need to take voting as it was not communicated in writing to BOS by MOA.

Dr. Sanjay Dhar said WE HAVE TO DISCUSS TODAY AND MENTIONED BOS IS NOT A DIST CHAPTER.

This was proposed by Dr. Rujuta Mehta and seconded by Dr. Harshad Argekar. This was passed by a majority of votes in the AGM.

Dr. Rajesh Gandhi announced the election results. The following members were elected unopposed:

- Dr. Gautam Zaveri as President Elect (Unopposed)
- Dr. Samir Dalvie as Vice President (Unopposed)
- Dr. Ashish Phadnis as Hon. Secretary (Unopposed)

The voting was done for two EC members and there were four applicants. The names were Dr. Sachin Kale, Dr. Vidyanand Raut, Dr. Jayesh Baviskar and Dr. Eknath Pawar.

Dr. Sachin Kale won by 197 votes and Dr. Jayesh Baviskar won by 149 amongst a total 358 BOS member voters.

20. Dr. L. N. Vora Master Cares Master Shares name as a permanent fixture as per letter received.

Dr. Rajesh Gandhi mentioned a brief BOS history from the time of Dr. R. J. Katrak and Dr. K. T. Dholakia to Dr. L. N. Vora and their contribution.

He suggested that as Late Dr. L. N. Vora being an excellent teacher to many of us - in our memory, his name comes first and it will last forever. So in his loving memory, his name should be given permanently for that academic activity.

BOS ROBOTIC ARTHROPLASTY FELLOWSHIP REPORT

I am Dr. Ankit B. Waghela. I did fellowship in Revision and Robotic Arthroplasty from 1st July, 2024 to 15th August, 2024 under the auspices by BOS and under the guidance of Dr. Mohan Desai. I am writing this report of my experience during this tenure.

Advantages

1. Experience with revision cases involving augments, long stems, bone loss, infections, and complications.
2. Exposure to robotic-assisted procedures.
3. Dr. Mohan Desai is an exceptional educator with a remarkable personality. As robotics was entirely new to me, he addressed all my queries, no matter how trivial.
4. This short-duration course is ideal for fellows who have previously performed Total Knee Replacement (TKR) or Total Hip Replacement (THR), or who are currently practicing.
5. Fellows have the opportunity to observe and assist in all cases throughout the course.
6. A stipend is provided.
7. The course initiated by BOS represents a forward-thinking approach to the education of recent graduates and sets an example for other professional bodies.

My suggestions

1. The duration of the course could be extended to 8 or 12 weeks.
2. A Follow up fellowship programme after 6 months to revise the technique and also to rectify fallacies in the technique we learned in initial program.
3. Fellows should be assigned at least one operating theater (OT) session per day as the first assistant.
4. It would be beneficial for fellows to observe cases from other units in addition to those assigned by the primary mentor, to gain exposure to various techniques employed by different surgeons.
5. Combining this course with other short-term specialty (spine, scopy) courses could enhance the comprehensive learning.

I would like to extend my gratitude to Dr. Ashish Phadnis for his guidance throughout the course.
